# Memorandum

**Subject:** 2015 Justice Assistance Grant

---

As indicated in the June 3, 2015 Notes to Council memo, the Police Department received notice of funds that would be received as part of the 2015 Justice Assistance Grant (JAG). The anticipated award for the 2015 JAG is \$25,305.00.

The Police Department has determined that the best use of these funds will be to continue with implementation of additional body-worn cameras. The JAG funding will allow for the purchase of approximately 25 body-worn cameras, bringing the total number of cameras in use by the department to approximately 60. This will further the department's goal of equipping each officer in the Field Operations Bureau (Patrol Officers) with a body-worn camera.
