WHEREAS, the commemoration should be conducted each September 11th throughout the land to include:

- The promotion of global peace and good will
- The celebration of love for humankind

Inclusive Community Breakfast

Cassandra Daniels stated the Inclusive Community Breakfast is scheduled for September 22nd at 2016 at the Greenville Hilton. The breakfast will start at 8:30 a.m. Staff suggested the Council consider having two speakers that will give their perspective on Trust, Respect and Unity. Judge James Wynn and Chief Mark Holtzman were suggested as possible presenters. The Council decided it would be best to just have one presenter and recommended staff check the availability of Judge Wynn. If he's not available, then we go with Chief Holtzman.

The Council discussed at length regarding Judge Wynn being a part of the judicial system, however, Judge Wynn was an attorney in the Greenville community for years prior to becoming a judge. His will be able to speak to the community because of his history in the community and because of his knowledge of the community; he will be able to speak how communities need to come together. Sister City Program

Byung Lee stated he visited Korea a few weeks ago and had the opportunity to visit Yeonsu, Korea. There population is approximately 350,000. They are requesting an official letter from the Mayor. They would like to have a cultural exchange program and student exchange program. They suggest the first two – three years is for building relationships and then officially we can join as an official sister city. They will provide room and board when we arrive and when they visit us, we will provide room and board. However, everyone will have to pay their airline expenses.

Byung Lee stated he checked with the Chamber of Commerce but they don't have anything going on at this time. It was suggested that members of the subcommittee (Samar Badwan, Jim Cox, and Byung Lee) met with representatives from Chamber of Commerce, Visitors and Convention Bureau, the Mayor and any others that have an interest in exploring the possibility of a Sister City Initiative with Korea.

Connecting People: Planting Seeds to Dismantle Racism

Byung Lee stated the next community dialogue is scheduled Thursday, October 27th at 6:00 pm. The dialogue is on the same night as the Council's regular meeting. The Council has to decide on the following:

- A joint or combined meeting with the dialogue,
- Reschedule the regular meeting to another date,
- Change the date for the community dialogue.

Cassandra Daniels stated a joint or combined meeting means it is noted there is a quorum of the Human Relations Council and a summary of the dialogue are the minutes. Byung Lee will have to open the dialogue just as he does for the Council's regular meeting. Also, the dialogue is scheduled at First Presbyterian Church. Rev. Neely suggested the Council consider other churches or places be used for the dialogue. The Council agreed with Rev. Neely and proposed the following churches are contacted for the October 27th dialogue: Sycamore Hill, KCC, Peace, Jarvis and Cornerstone.

A motion was made by Samar Badwan, seconded by Heena Shah, that the Council hold a joint meeting on Thursday, October 27^{th} at 6:00 pm. Motion carried unanimously.

Cassandra Daniels stated the Christmas luncheon for Senior Citizens will take place on Thursday, December 1st at 11:30 am. The event will be held at the Drew Steele Center.

2017 Annual Awards Ceremony
