VIII. DEPARTMENT REPORTS

- A. Public Works (Lynn Raynor)
 - 1. Ramp Improvements

Focus is on the Uptown Greenville area, West Greenville, and the University District north of 5th Street. City staff has provided NCOT with a list of approximately 375 ramps. The City's cost share will be 20%.

- South Tar Greenway Phase III Continue to wait to hear from CSX.
- 3. Arlington from Red Banks to Fire Tower Milling and repaving will begin on 4/10 and to be completed within 60 days (60 day contract). Staff has been directed to stripe this portion of Arlington differently than the portion between Memorial Drive and Stantonsburg Road. Staff will present to City Council defending the reason it was striped the way it was. Citizens can contact
- Councilmembers with any complaints or in support of restriping.
- 4. Intersection Pedestrian Improvements Intersection improvements include signals and concrete ramps that are ADA accessible. Fifteen (15) intersections the COG is performing concrete work and the NCDOT is completing pedestrian signals. The City's work is complete. NCDOT should finish within the next couple of months.
- 5. Annual Street Resurfacing Contract

At the 4/10 City Council meeting the City Council approved the annual street resurfacing contract. A motion was made for the Commission to write a statement of support for bicycle lanes on these new resurfacing projects.
