ENVIRONMENTAL ADVISORY COMMISSION MINUTES January 3, 2019

CALL TO ORDER

Members of the Environmental Advisory Commission met on the above date at 5:30 p.m. in the City Council Chambers. Durk Tyson, Chairperson, called the meeting to order and welcomed all those present. The following attended the meeting:

3. ADDITIONS/DELETIONS/APPROVAL OF AGENDA

A motion was made by Dr. Kane to approve the agenda as presented. The motion was seconded by Mrs. Maxwell and passed unanimously.

4. APPROVAL OF NOVEMBER 1, 2018 MINUTES AND DECEMBER 6, 2018 MINUTES

Mr. Tyson asked for a motion to approve the November 1, 2018 EAC minutes. Mrs. Maxwell observed the Cupola building spelling in Announcements and requested it be corrected. Mr. Brinkley made a motion to approve the November 1, 2018 meeting minutes with the correction. The motion was seconded by Mrs. Maxwell and passed unanimously.

Mr. Tyson asked for a motion to approve the December 6, 2018 EAC minutes. Dr. Ames noted that Item 7A had some verbiage missing and asked that the governor had issued an executive order to address climate change and transition to a clean energy economy. A motion was made by Mr. Brinkley to approve the December 6, 2018 as amended with a second by Mrs. Maxwell. The motion passed unanimously.

Dr. Kane reminded members of the draft resolution regarding proposed rollbacks to the Clean Water Act that she had sent for review. A discussion followed. Daryl stated that City staff had reviewed the implications of the changes, and that although it did not appear the City would be impacted by the changes, clarification is needed to determine the potential future impacts to the City. Final rule publication has not yet taken place in the Federal Register due to the government shutdown.

6. PUBLIC COMMENT PERIOD

Mr. Carwein was present for Public Comments as he did not have a Sustainability Report for ECU. Mr. Carwein stated the Sierra Club would be doing a road side clean up on Corey Road on Saturday, January 5, 2019 at 10am beginning at Covenant Church. The monthly Sierra Club program will be January 14, 2019 Unitarian Universalist Congregation at 7pm. Lisa Kirby will be the speaker discussing the Town Creek Culvert Project. Mr. Carwein also announced that FROGGS will be holding their friend-raiser at Pitt Street Brewery on January 26, 2019 from 4-6:30pm. Mr. Carwein stated the dates

for the film series dates have been set and will be reported at the February meeting of EAC.

Mr. Carwein stated the Sustainability Plan for ECU has been printed and are also available online if any member is interested.

Dr. Kane asked that discussion of the Sustainability Officer be added to the calendar. Mr. Norris will make contact with the City Manager's office to determine a date that Ms. Wall may be able to attend to continue discussion. Mrs. Maxwell stated she would also like to have someone to speak to EAC regarding Air Quality. Dr. Ames will pursue a speaker to address EAC regarding air quality and impacts on health. Dr. Kane and Mrs. Maxwell will work together to identify a speaker and topic and will provide information to Staff to add to the EAC calendar.
