Title of Item: Update to Boards and Commissions Program

Explanation: **Abstract:** The City Council has expressed a desire to examine the effectiveness and efficiency of their Boards and Commissions program. Information will be provided on results of the analysis.

Explanation: The City Clerk's Office sent out a survey and met with members of staff to discuss practices of each board and commission. Based on feedback received, the City Clerk's Office explored the following measures:

- merge boards that share a similar scope
- define resources available to boards and commissions
- implement orientation sessions for new staff liaisons and board chairs
- create a standard for City Council items that outlines when a committee's input is needed
- change format of the boards and commissions presentations to City Council
- modify the application process to make it more accessible and keep the information current
- implement a regular, formal recognition of boards and commissions members

Title of Item: Presentation of Information for the Consideration of Special Assessments for Street Improvements

The presentation will review General Statutes requirements and options for addressing road issues.
