I. APPROVAL OF AGENDA

II. PUBLIC COMMENT PERIOD

There were no public comments.

III. ELECTION OF TECHNICAL COORDINATING COMMITTEE AND TRANSPORTATION ADVISORY COMMITTEE CHAIR AND VICE CHAIR FOR 2020

Ms. Kirby made a motion to retain the current officers for TCC as Kevin Mulligan for Chairperson and Ben Williams as Vice-Chairperson. Mr. Taylor seconded the motion and passed unanimously.

Mayor Zeck made a motion to retain the current officers for TAC as P.J. Connelly for Chairperson and as Vice-Chairperson. The motion was seconded by Mr. Moore and passed unanimously.

IV. CONSENT AGENDA

A. Approval of the December 11, 2019 Joint TCC and TAC Meeting Minutes

A motion was made by Mr. Williams to approve the December 11, 2019 meeting minutes for TCC. The motion was seconded by Mr. DiCesare and passed unanimously.

A motion was made by Mayor Zeck to approve the December 11, 2019 meeting minutes for TAC. The motion was seconded by Mr. Moore and passed unanimously.

B. Minor Amendments to the 2018-2027 Metropolitan Transportation Improvement Program (MTIP)

In November 2019, the City of Greenville was awarded a United States Department of Transportation Better Utilizing Investments to Leverage Development (BUILD) grant. Greenville will receive federal funds to support its Transportation Access, Safety and Connectivity (TASC) Investment Project, a multimodal improvement project to enhance the city's vehicle, pedestrian, and bicycle infrastructure. The projects will include roadway realignment and resurfacing, as well as the extension of greenway space, construction of a multi-use path, and conversion of an abandoned rail. Each project submitted is contained within either the 2019-2045 Metropolitan Transportation Plan (MTP) or the Comprehensive Transportation Plan (CTP) as is required by project eligibility. The projects will be administered by the City of Greenville. All federally funded projects must be included on the Statewide Transportation Improvement Program (STIP) or (Transportation Improvement Program) TIP.

Other minor amendments to the MTIP include:

1. U-6240 (West 5th Street, from Cadillac Street to Reade Circle, Rehabilitation and Realignment Project) Programmed for Preliminary Engineering and Construction

2. EB-6042 (South Tar River Greenway, from the Town Common to the Veterans Administration Clinic along Moye Boulevard, Construct Multi-Use Trail) Programmed for Construction

3. EB-6043 (Town Common Connector, from Town Common to East 5th Street, Construct a Multi-Use Path) Programmed for Preliminary Engineering and Construction

4. EB-6044 (Millennial Connector Path, from Dickinson Avenue to 10th Street and from Dickinson Avenue to Ficklen Street, Construct Multi-Use Path) Programmed for Preliminary Engineering and Construction

5. EB-6045 (Moye Boulevard, along Moye Boulevard, Construct a Multi-Use Path to replace existing sidewalk) Programmed for Preliminary Engineering and Construction.

No action was required for this item.

C. Minor amendment #2 to the Greenville Urban Area MPO's FY 2020 Unified Planning Work Program

The Greenville Urban Area Metropolitan Planning Organization's (MPO) Transportation Advisory Committee (TAC) approved the Fiscal Year (FY) 2019-2020 Unified Planning Work Program (UPWP or PWP) on February 6, 2019 and amended on July 10, 2019. The UPWP represents the MPO's planned activities and expenditures for the designated fiscal year and is required to be prepared yearly.

Staff is proposing to amend the current UPWP in order to reallocate existing funds update planned expenditures for on-going tasks in 2019-2020. The MPO needed to adjust planned expenditures to accommodate projects requiring additional funds. The MPO also added language regarding the coordination and planning of the NCAMPO 2020 Conference in the task narrative of the III-D Statewide and Extra-Regional Planning section.

The following updates are proposed in Amendment #2 to the FY2020 PWP:

- 1. Re-Allocation of Federal PL Funds Programmed within the Current UPWP to add funding for Pitt County CTP development assistance, NCAMPO Conference Preparation and Program Administration.
- 2. Addition of the NCAMPO 2020 Conference participation in the task narrative.
- Mr. Williams made a motion to recommend TAC adopt the resolution to amend the UPWP.

The motion was seconded by Mr. DiCesare and passed unanimously.

Mayor Zeck made a motion to adopt the resolution by TAC. The motion was seconded by Mr. Moore and passed unanimously.

D. Support of the State's Established Safety Performance Measure Targets

Current federal transportation legislation (FAST Act) requires states and MPOs adopt performance measures and targets to monitor their progress over time toward achieving USDOT transportation goals. Safety was the first area of emphasis for FHWA and guidance reflects that the following should be considered by states and MPOs when developing performance measures/targets:

- Number of fatalities
- Fatality Rate (per 100 million VMT)
- Number of Serious Injuries
- Serious Injury Rate (per 100 million VMT), and
- Number of Non-motorized (Pedestrians + Bicyclists) Fatalities and Serious Injuries

NCDOT adopted associated safety performance measures in August 2019 for the 2020 calendar year. As such, the Greenville Urban Area MPO is required to adopt safety measures by the end of February 2020. While the FAST Act allows MPOs to adopt measures and targets independently of their state, NCDOT has encouraged MPOs to follow their lead by adopting the established statewide performance measures. These updated safety targets must also be included in the Long Range Transportation Plan (LRTP) as well. Staff is recommending an administrative update to add the 2020 Safety Targets to the Plan.

These five specific criteria must be updated on a yearly basis with the following benchmarks adopted by NCDOT for 2020:

1. For the 2020 Highway Safety Improvement Plan (HSIP), the goal is to reduce total fatalities by 6.23 percent each year from 1,396.4 (2014-2018 average) to 1,227.8 (2016-2020 average) by December 31, 2020.

2. For the 2020 Highway Safety Improvement Plan (HSIP), the goal is to reduce the fatality rate by 5.39 percent each year from 1.211 (2014-2018 average) to 1.084 (2016-2020 average) by December 31, 2020.

3. For the 2020 Highway Safety Improvement Plan (HSIP), the goal is to reduce total serious injuries by 8.54 percent each year from 3,362.6 (2014-2018 average) to 2,812.8 (2016-2020 average) by December 31, 2020.

4. For the 2020 Highway Safety Improvement Plan (HSIP), the goal is to reduce the serious injury rate by 7.64 percent each year from 2.886 (2014-2018 average) to 2.462 (2016-2020 average) by December 31, 2020.

5. For the 2020 Highway Safety Improvement Plan (HSIP), the goal is to reduce the total nonmotorized fatalities and serious injuries by 7.13 percent each year from 494.6 (2014-2018 average) to 426.6 (2016-2020 average) by December 31, 2020.

The goals adopted by the MPO will be contained in the MPO's 2045 Metropolitan Transportation Plan (MTP) and will be updated yearly. With the inclusion of the performance measures in the MTP, seamless and efficient connection between the performance measures and potential projects will exist within the plan allowing all projects listed in the MTP to support the required performance measures (with yearly updates required to the measures).

A motion was made by Mr. Williams to recommend adoption by TAC. The motion was seconded by Mr. DiCesare and passed unanimously.

A motion was made by Mayor Zeck to adopt the Resolution of Support. The motion was seconded by Mr. Moore and passed unanimously.

V. REGULAR AGENDA

A. Self-Certification of Greenville Urban Area MPO Transportation Planning Process for FY21 It is federally required that MPO's certify that their planning processes are compliant with all federal regulations for the upcoming fiscal year (2021). As a non "Transportation Management Area, or TMA, (MPO with 200,000 or more citizens)", it is permissible for the MPO to "selfcertify" its practices by completing the attached Self Certification Checklist and providing it to NCDOT for review and confirmation. Staff has reviewed and confirmed that all planning practices and processes undertaken by the MPO are compliant with all applicable Federal and State regulations. Staff and the TCC recommend adoption of the MPO's self-certification to the Transportation Advisory Committee (TAC).

A motion was made by Mr. Taylor to recommend for TAC adoption. The motion was seconded by Mr. DiCesare and passed unanimously.

A motion was made by Mayor Zeck to adopt the resolution for the self-certifying process for GUAMPO. The motion was seconded by Mr. Moore and passed unanimously.

B. Review and approval of the Fiscal Year 2021 Unified Planning Work Program (UPWP)

The Unified Planning Work Program (UPWP) is a federally mandated document that must be prepared yearly. The purpose of the UPWP is to illustrate the activities and expenditures anticipated by the MPO for the coming fiscal year. The MPO receives a yearly allocation of funding and rolls over funding from previous years that must be programmed and allocated to specific tasks and responsibilities such as regional planning, Prioritization, maintenance of the Metropolitan Transportation Improvement Program (MTIP), Title VI initiatives, Public Involvement etc. In FY 2020 the State of North Carolina has adjusted their allocation methodology no longer allowing MPO's to roll over past year funds. This change led staff of the MPO to coordinate with NCDOT and gain approval for the 2021 UPWP in order to program the requisite number funds proposed in the draft. The proposed UPWP for FY 2021 was developed utilizing information provided by representatives of the MPO's participating communities and coordinated with NCDOT's Transportation Planning Division. The City of Greenville's Transit Manager provided information regarding future FTA-sponsored planning activities and needs as necessary for system specific funding. MPO projects and special studies anticipated in the 2020-2021 period include: • Pitt County - CTP update assistance (Task II-B-2, Regional Planning) • NC43/Charles Blvd Corridor Study (Task II-B-3, Special Studies) • Uptown Greenville Area and Mobility Plan (Task II-B-3, Special Studies) • Sidewalk Evaluation Study (Task II-B-3, Special Studies) A 5-year work plan be submitted and updated to keep NCDOT abreast of long-range planning issues. This requirement was initiated by NCDOT for the 2009-2010 planning period and outlines the major initiatives the MPO plans to undertake creating efficient communication between NCDTO, FHWA and the MPO.

A motion was made by Mr. Williams to recommend for TAC adoption. The motion was seconded by Ms. Kirby and passed unanimously.

A motion was made by Mayor Zeck to adopt the resolution for the self-certifying process for GUAMPO. The motion was seconded by Mr. Moore and passed unanimously.



Purpose & Goals

The awareness and involvement of interested persons in governmental processes are integral to successful transportation planning. The Public Involvement Plan (PIP) of the Greenville Urban Area MPO sets forth specific measures to heighten citizen education and responsiveness.

Public involvement helps avoid, minimize, and mitigate project impacts while providing the best engineering solutions. Therefore, to be effective, it is important that government agencies understand a given community's values and, it is equally important for the community to understand the tradeoffs and constraints associated with project planning.

This mutual understanding can only be achieved through early, frequent and continuous communication. When the public is engaged in the process, their insight helps assure projects suit community needs, simultaneously complementing the movement of people and goods. This Plan identifies the methods the Greenville Urban Area MPO currently uses and will implement in the future to optimize public participation in developing transportation projects.

The goals of this policy are to:

- Inform the public of transportation meetings, events, projects and objectives.
- Educate the public regarding the role of transportation planning and the decision-making process.
- **Involve** the public by providing as many possible involvement opportunities in the transportation planning process and decision-making.
- **Reach out** to all communities in the planning area to educate, inform and involve.
- **Improve** the public involvement process by reviewing this policy yearly for potential improvements and every years in accordance with federal law.

Federal Requirements for Public Participation

There are several laws and regulations that have been established by the Federal government to ensure the transportation planning process remains open and in the public interest. The following is a list of federal legislation and regulations that guide the public participation process:

Fixing America's Surface Transportation Act (FAST Act) (PL 114-94) emphasizes participation by interested parties in the transportation plan:

A In General: Each metropolitan planning organization shall provide citizens, affected public agencies, representatives of public transportation employees, public ports, freight shippers, providers of freight transportation services, private providers of transportation (including intercity bus operators, employer-based commuting programs), representatives of users of public transportation, representatives of pedestrian walkways and bicycle transportation

GUAMPO is governed by the Transportation Advisory Committee (TAC) and the Technical Coordinating Committee (TCC), which serves as an advisory group to the TAC. Details concerning membership of these committees are available in Appendix B.

Meetings of the TAC and TCC are open to the public, and meeting agendas and minutes are public record and can be accessed. Past minutes and agendas are available upon request from the LPA, the MPO's website or the City of Greenville's Engineering Department located at 1500 Beatty Street, Greenville, NC 27834.

Each TCC and TAC meeting shall include a public comment period in accordance with the MPO's public comment policy as outlined below:

The TCC and TAC hereby establish a public comment policy as follows:

- The TCC and TAC shall have an open formal public comment period during each meeting at the determination of the chairperson. Public comment shall occur as established in this policy.
- The Public Comment Period is a period reserved for comments by the public. A total of 30 minutes is allocated. The allowable duration of each speaker's time shall be determined by the chairpersons of the TCC and TAC, recommended not to exceed three (3) minutes per speaker.

Typically, meetings of both the TCC and TAC boards will be held by an in-person format, with each member agency represented. In the event an in-person meeting cannot be accomplished, meetings may be conducted by one or more means of remote communication through which all of the Members may participate with each other during the meeting, if the number of Members participating is sufficient to constitute a quorum.

If electronic meetings are held, these updates and meeting information are posted on the GUAMPO website and/or social media pages, with guidance for the public in how to participate.

The TCC and TAC meetings shall be advertised in the *Daily Reflector* newspaper a minimum of five (5) calendar days prior to the meeting. If an interpreter is needed for deaf or hearing impaired citizens, please call 252-329-4522 (voice) or 252-329-4060 (TDD) no later than two business days prior to the meeting. All MPO meetings are held at a location accessible to people with disabilities and special provisions can be made for anyone with disabilities who wish to participate.

Transportation Advisory Committee (TAC)

The Transportation Advisory Committee serves as a forum for cooperative transportation planning decision making for the Metropolitan Planning Organization. They approve all federal aid transportation funds in the metropolitan area. The Transportation Advisory Committee has the responsibility for keeping the public informed of the status and requirements of the transportation planning process; assist in the dissemination and clarification of its decisions, inclinations, and policies; and ensures meaningful citizen participation in the transportation planning process. The TAC is comprised of elected officials from each MPO member and a member of the NCDOT Board of Transportation.

Technical Coordinating Committee (TCC)

The Technical Coordinating Committee is responsible for providing technical assistance and advice to the Transportation Advisory Committee. The Technical Coordinating Committee provides the general review, guidance, and coordination of the transportation planning process for the planning area and has the responsibility for making recommendations to the Transportation Advisory Committee regarding any actions relating to the continuing transportation planning process.

The Transportation Technical Coordinating Committee is comprised of technical experts from local and state governmental agencies directly related to and concerned with the transportation planning process for the planning area. The membership shall include, but not be limited to, representatives from all of the jurisdictions of the Transportation Advisory Committee. The committee membership is flexible.

Ongoing Public Involvement Opportunities

Opportunities for public input include, but are not limited to, the following:

- **Planning Documents** All documents, agendas, resolutions, meeting minutes, etc. adopted by the GUAMPO are kept at the City of Greenville Engineering Department (LPA) offices at 1500 Beatty Street, Greenville, NC. These documents will be made available for public review upon request and will be available on the MPO's web site.
- Web Site The web site provides an ongoing opportunity for public comment via email and is an easy and convenient way for the public to be informed and involved in the transportation planning process. The website will be maintained and routinely updated by GUAMPO staff. The website contains the following information:
 - Available information on specific projects that are currently in the planning stages
 - Organization Chart of MPO members
 - Staff contacts
 - Publications
 - ► Information / Links to Area Highway Projects / Other Agencies
 - Links to allow the public to provide comment to any MPO-related matter.
 - MPO related documents such as: LRTP, ATP, PWP, MTIP, CTP, POP, PIP, Local Area Plans/Studies
 - Meeting minutes & agendas
- Fax comments to 252-329-4535
- **Drop off comments in person to -** City of Greenville, Engineering Department, 1500 Beatty Street, Greenville, North Carolina, 27834. This may be done Monday-Friday, between 8:00 am through 5:00 pm.
- Mail Comments may be mailed to City of Greenville, Engineering Department, 1500 Beatty Street, Greenville, North Carolina, 27834

- **Surveys -** Surveys are used to obtain general input from the public on transportation matters. They ask the public about transportation issues and concerns and some demographic information. Surveys are also used to gather specific technical data during planning studies. For example, the 2006 Origins and Destinations study surveyed people driving within the GUAMPO area about their travel habits.
- **Comment Forms** Comment forms are used to solicit general public comments at openhouse meetings and/or other public meetings. Comments may also be submitted on the GUAMPO website to solicit input regarding any current or future project. Comment forms can be either general or very specific in nature. A comment form may request general feelings about any aspect of transportation or to help identify preferred alignment alternatives considered during a corridor study.
- **Public Workshops** Public Workshops are used to both present information and solicit public comment on a plan or issue being considered by GUAMPO. Public comments are recorded and a summary provided to the Transportation Advisory Committee. Public workshops include visual aids such as maps, aerial photographs, and drawings to facilitate public understanding and are typically help at ADA-complaint Sheppard Memorial Library.
- **Innovative Techniques** GUAMPO shall utilize innovative techniques recommended by the public in an effort to engage all members of the public.

Response to Public Input

Public involvement may be documented in a variety of ways. Any comments received during a meeting of the GUAMPO's TCC or TAC will be included in the meeting minutes. Comments received during workshops, open houses, or presentations to civic organizations will be summarized, presented to the TCC and TAC, and kept on file. Results of surveys will be compiled, summarized, presented to the TCC and TAC, and kept on file.

Public comments may be included as appendices in formal documents or plans for which they were made.

- The document(s) are presented to the TAC for their consideration and adoption.
- The Greenville Urban Area MPO shall provide for an additional public comment period of at least 10-calendar days if the final CTP differs significantly from the version that was made available for public comment by the MPO and raises new material issues which interested parties could not reasonable have foreseen from the public involvement efforts.
- The document(s) are presented to NCDOT's Board of Transportation for adoption.

Greenville Area Transit (GREAT) Program of Projects (POP)

On an annual basis, the MPO, on behalf of the GREAT system, shall publish a POP to ensure that the public is aware of any federal expenditures (with associated public transportation activities planned for each fiscal year). The POP will be published on the MPO website and available in print at the City of Greenville Engineering Department, 1500 Beatty Street, Greenville NC. The MPO shall advertise the proposed POP in a local newspaper at least 10 days prior to consideration for adoption by the City of Greenville City Council to allow for public review and comment. All comments received shall be provided to the City Council for consideration. A public hearing may be held during a regularly scheduled City of Greenville City Council Meeting in concurrence with any public hearing regarding the 5307 Federal Grant.

Public Involvement Plan (PIP)

To ensure all interested persons have the opportunity to comment, before adopting or amending the PIP, the MPO provides a public comment period of 45-days. The draft PIP is also posted on the MPO's website. Those interested persons requesting a printed copy of the draft PIP may call 252-329-4476. Once the MPO approves the PIP it is placed on the MPO web site.

• Before it was adopted, this plan was available for public review and comment from December 18, 2018 through February 14, 2018. (at least 45 days). Appendix A summarizes comments received during the specified public comment period.

Disadvantaged Business Enterprise (DBE) Policy Statement

The Greenville Urban Area MPO shall not discriminate in any manner on the basis of race, color, sex or national origin, and shall take all reasonable steps to ensure that certified Disadvantaged Business Enterprises (DBE's) have the maximum opportunity to participate in the performance of contracts financed, in whole or in part, with financial assistance from the United States Department of Transportation (DOT), acting through such agencies as the North Carolina Department of Transportation (NCDOT) and the Federal Highway Administration (FHWA). The Greenville Urban Area MPO shall implement this DBE Policy in accordance with Part 26 of Title 49 of the Code of Federal Regulations entitled "Participation by Disadvantaged Business Enterprises in Department of Transportation Programs."

The policy of the Greenville Urban Area MPO is:

- To ensure nondiscrimination in the award and administration of DOT-assisted contracts;
- To ensure that the DBE program is narrowly tailored in accordance with applicable federal, state and local laws;
- To ensure that only firms fully meeting the eligibility requirements of the DBE program are permitted to participate;
- To help create a level playing field on which DBEs can fairly compete for DOT-assisted contracts;
- To help remove barriers to the participation of DBEs in DOT-assisted contracts;
- To help and assist in the development of firms that can compete successfully in the marketplace outside of the DBE program; and
- To provide appropriate flexibility to establish and provide DBEs opportunities to participate in DOT-assisted contracts in accordance with applicable federal, state and local laws.

The Department will disseminate the policy to all MPO members. We will use the following methods to disseminate the policy:

- Inclusion in the Agenda package for regular TCC and TAC meetings for the policy's review and adoption.
- Publish it in the Public Involvement Plan
- Publish it on the MPO's web site as a part of the Public Involvement Plan.

The NC Department of Transportation (NCDOT) serves as the certifying agency for all DBEs seeking work on GUAMPO-related contracts.

The NCDOT's Unified Certification Program, (UCP) is a "one-stop shopping" certification procedure that will eliminate the need for Disadvantaged Business Enterprise (DBE) firms to obtain certification from multiple agencies within the state. The firm can now apply one time with the NCDOT, and if approved, that certification is shared by all other federal recipients in the state, including the Greenville Urban Area MPO.

Firms must apply for certification as a DBE to NCDOT by completing the UCP application located on the NCDOT's Web site. Detailed instructions on how to become certified as a DBE under the UCP are listed on the site.

The NCDOT maintains a unified <u>DBE directory</u> that will contain all firms certified by the UCP, the information required by 49 CFR Part 26.31, and make it available to the public electronically, on the internet as well as in print.


FILING OF COMPLAINTS

- 1. Applicability These procedures apply to the beneficiaries of our programs, activities, and services, such as the members of the public and any consultants/contractors we hire.
- 2. Eligibility Any person or class of persons who believes that he/she has been subjected to discrimination or retaliation prohibited by any of the Civil Rights authorities based upon race, color, national origin, sex, age, or disability, may file a written complaint. The law prohibits intimidation or retaliation of any sort. The complaint may be filed by the affected individual or a representative, and must be in writing.
- **3.** Time Limits and Filing Options A complaint must be filed no later than 180 calendar days after the following:
 - > The date of the alleged act of discrimination; or
 - > The date when the person(s) became aware of the alleged discrimination; or
 - ➢ Where there has been a continuing course of conduct, the date on which that conduct was discontinued or the latest instance of the conduct.





<u>Purpose:</u> Amend the Greenville Urban Area MPO's current Fiscal Year (FY) 2019-2020 Unified Planning Work Program (UPWP) to re-allocate existing programmed funds to on-going tasks.

<u>Discussion</u>: The UPWP represents the MPO's planned activities and expenditures for the designated fiscal year and is required to be prepared yearly. The Greenville Urban Area MPO's Transportation Advisory Committee (TAC) approved the FY 2019-2020 UPWP on February 6, 2019 and the last amendment was on February 26, 2020.

Staff is proposing to amend the current UPWP in order to reallocate existing funds and update planned expenditures for on-going tasks in 2019-2020. The MPO added language regarding the preparation of the Floodplain Management Plan and the addition of the ADA curb ramps survey within the Pavement Condition Study. Back in November 8, 2017, the Floodplain Management Plan was approved by the MPO's governing committees to be included in the 2017-2018 PWP. The plan was not developed until this fiscal year.

The following language will be added in Targeted Planning (Task 2-B-1):

• The City of Greenville is preparing for flood hazards by developing a Floodplain Management Plan (FMP). A Flood Mitigation Plan for the City of Greenville will augment their Watershed Master Plans by providing enhanced flood-related information that will evaluate in more detail all flood hazards including a robust assessment of how the flood hazards impact repetitive loss properties in the City and those nearby or adjacent properties which currently only have one loss against the NFIP. The Floodplain Mitigation Plan will build upon the seven City of Greenville Watershed Master Plans with analysis of flooding hazards specific to culvert level of service for local and state roads, as well as pedestrian and rail corridors. This analysis will identify the transportation infrastructure susceptible to flooding hazards as well as proposed mitigation actions and improvements to increase level of service of these transportation routes in the face of increasing runoff from existing and future development and extreme storm events.

The following language will be added to the Pavement Condition Analysis in Special Studies (Task 2-B-3):

• ADA curb ramp compliance survey for Greenville, Winterville and Ayden will be performed.

Targeted Planning (Task 2-B-1) funds were increased to cover equipment purchases and the development of the Floodplain Management Plan. Funds for Uptown Area and Mobility Plan were removed as the plan will start next fiscal year and funds have been allocated in the 2020-2021 UPWP and the remaining needed funds will be added in 2022.

<u>Action Needed</u>: Request the TAC approve of resolution 2020-06 adopting Amendment #3 of the FY 2020 PWP.



<u>Purpose:</u> To discuss the Prioritization 6.0 timeline and review and approve the updated project list. Discuss additional projects to be added to the list.

<u>Discussion</u>: The North Carolina Department of transportation (NCDOT), Rural Planning Organizations (RPO) and Metropolitan Planning Organizations (MPO) undergo a process known as Prioritization every two (2) years to evaluate and program projects in the federally required State Transportation Improvement Program.

For P6.0, the current cycle, the MPO received sixteen (16) project submission slots in each mode of transportation (highway, bike & ped, rail, public transportation, aviation and ferry). Project submission totals are determined by the population and number of lane miles in the MPO.

Staff has added and made changes to the project list for review by the MPO's governing committees. Staff and TCC request the TAC approve the subsequent project list for submission in P6.0.

Staff is also sharing the updated Prioritization 6.0 schedule. The new submittal deadline for all P6.0 submittals will now be Friday, July 31st. The resulting scores from Prioritization 6.0 will guide the development of the future draft 2023-2032 STIP which now has a planned release in May 2022. The date for the adoption of the final STIP will be in Fall 2022.

<u>Action Needed</u>: Request the TAC approve the Greenville Urban Area MPO's Project List for Prioritization 6.0.
