### Public Hearings

 Consideration of an ordinance (requested by Evans Street Four, LLC) to rezone two tracts totaling 8.323 acres located along the eastern right-of-way of Evans Street, 250<u>+</u> feet south of Bradbury Road, south of Fork Swamp Canal, and east of Coastal Agrobusiness Corporation as follows: Tract 1 from R6 (Residential [High Density Multi-family]) to O (Office) and Tract 2 from R6 (Residential [High Density Multi-family]) to O (Office). The Planning and Zoning Commission at its April 19, 2005 meeting voted to **deny** the request.
