VI. DIRECTOR'S MONTHLY REPORT

- A. The impacts of Covid-19 on Recreation and Parks services are numerous, because staff has to consider not only the well-being of the people who utilize our services, the customers, but also the well-being of the people who provide those services, staff and volunteers. While most services traditionally offered have been impacted, I'm proud and grateful for staff's efforts to not allow the pandemic to totally eradicate those services and the positive impacts they have on our community and citizens. Assistant Director of Recreation and Parks and his staff have led the endeavor and he'll share more about that during his report. It's truly been a heroic effort as he and the staff continued to press forward despite the ongoing challenges, frustrations, and discouragement.
- B. You may recall last fall I mentioned the Chamber of Commerce would featuring the Sycamore Hill Gateway Plaza Project at the Town Common in their 2021 edition of *Glimpse* Magazine and this year's edition arrived last week. We'll send you a copy. In general, the Chamber has been willing to feature some aspect of our department's efforts and impacts in each edition of *Glimpse*. This year's article is entitled, "A Vision Finally Realized," reflecting how long ago we envisioned and began working on development of the Sycamore Hill Gateway Plaza. A plus for us and for the project is a gateway photo is featured on the cover and we'll have copies of *Glimpse* available at various facilities.
- C. City Council approved the name "Wildwood Park" for the Adventure Park on the north bank of the Tar River. You may also know, thanks to a \$550,000 donation, the City will soon add 185 acres on the west side of Greenville Boulevard to a similar amount of acreage on the east side. Staff has hoped for and been working toward the land becoming part of the park for quite some time and thanks to this generous gift, it's finally going to happen. The vision for the park is pretty vast and in the months to come we'll be seeking grants and partners that might assist financially with various aspects of Wildwood's development. Though Parks Planner Mark Nottingham will report on some of the projects that are being addressed at Wildwood, Director Fenton shared individual images of some of the possible future components the potential amenities that may become a part of the park as it develops over time. The addition of any of features will be contingent upon the ability to identify the necessary funding for the particular feature, whether that be from a corporate or non-profit sponsorship, a donation, a grant, the City's capital budget, or a combination of it all. Director Fenton shared a detailed PowerPoint regarding the development of Wildwood.

This is not an inclusive list, there could be others and some that were mentioned may not be added. Adding an amenity is first, a matter of appropriateness: Does it fit in a park like this? Secondly, has funding been identified for this particular feature? And thirdly, does staff feel confident the annual budget will include funds to allow for the operation and maintenance for that feature? Through it all, we must continually remember the most important aspects of Wildwood will be its natural ones, its meadows, forests, river and streams, lakes, and wetlands. As staff plans for capital improvements, we must assure that our planning efforts prioritize the protection of the natural features that already exist.

VII. ASSISTANT DIRECTORS REPORT

- A. Current Operations Update
 - 1. Shared Current Operations Update.
 - Recreation Centers are open limited hours and the operating hours at each facility are dependent on current programming.

- GAFC is still operating at a limited capacity with various safety measure being implemented.
- Shelter rentals continue for groups of 50 or less, with safety guidelines.
- Indoor building rentals have been suspended due to gathering limits of only 10 individuals indoors. Once this limit increases staff will re-evaluate building rentals.
- Staff is not allowing any rentals at the Town Common due to gathering limits. This
 continues to be evaluated with each update of the Executive Order and is subject to
 change.

B. Parks Division Report

- 1. Dean Foy, Parks Superintendent
 - a. Beginning renovations of Skate Park beginning 3/20. Staff will be replacing the skate lite and the substructure and square tubing. Will take approximately 24 weeks to complete. Staff will do the work between 8am 3pm, park will remain open and available for use.
 - b. New employee, Michael Turner is on staff in Parks Division. Will be responsible for special events and the Town Common. Hope is to elevate the standard at the Town Common. Will have a full time staff member supporting these events and will eventually have part time staff working for him as well. His first big event is The Beast of The East Soccer Tournament at the Soccer Complex.
 - c. Currently cleaning from a mud event at the Town Common. Also on the greenway.

 - i. Facility Overview
