- 4. Sales taxes may be listed on the proposal, but as a separate item. No charge will be allowed for Federal Excise and Transportation Tax from which the City is exempt.

### 1.0 SCOPE:

The scope of work shall include, but is not limited to:

- 1.1 Environmental decontamination
- 1.2 Pigeon eradication
- 1.3 Demolition of existing fly loft
- 1.4 Interior cleaning
- 1.5 Partial repair of main building roof framing
- 1.6 Roofing of existing fly loft
- 1.7 Exterior Repair for weather proofing purposes

This will be a turn-key project. The project time duration shall be  $\underline{120 \text{ days}}$ . The time will start from the contract award and the notice to proceed and end at final approval and submission of required paperwork. Permit fees will be waived for this project but the contractor is required to obtain a building permit and have all required inspections performed per all North Carolina Building Codes.

### Notes:

- The contractor cannot close 5<sup>th</sup> Street during the hours of 8am to 5pm, Monday Saturday, unless with owner's approval. During any events scheduled Uptown or at the 5 Points Plaza also shall not be affected.
- Any traffic modifying activities to occur outside of construction fencing is to be approved by the Owner.
- Parking for contractors shall be at the parking lot at the corner of Pitt and 4<sup>th</sup> Streets.
- All existing curbs, asphalt, stripping, brick pavers, landscaping, etc. must be protected or repaired to current conditions at the end of the project.
- All work specified herein must be done while protecting surrounding businesses and persons from damage or injury.

### 2.0 PAYMENT AND BID:

- 2.6 Equal Employment Opportunity Clause

The City has adopted an Equal Employment Opportunity Clause, which is incorporated into all specifications, purchase orders, and contracts, whereby a vendor agrees not to discriminate against any employee or applicant for employment on the basis of race, color, religion, sex, national origin or ancestry. ### 3.0 WORKERS COMPENSATION AND INSURANCE:

- 3.1 The contractor must maintain during the life of this contract, Worker's Compensation Insurance for all employees working at the project site under this contract, or as otherwise required by North Carolina General Statutes.
- 3.2 The Contractor shall have in place for the life of this contract public liability and property damage insurance and shall protect the City of Greenville and the Redevelopment Commission from claims for damage or personal injury, which may arise from operations under this contract. The amounts of such insurance shall not be less than \$500,000 for injuries subject to the same limit per person and \$1,000,000 for property damage or otherwise needed to protect the interests of the owner. The Contractor awarded this contract is to provide a Certificate of Insurance showing the City of Greenville and the Redevelopment Commission named as an additionally insured firm on all coverage. All insurance must be maintained during the duration of the contract.

### 3.3 OTHER INSURANCE:

The contractor shall furnish such additional insurance as may be required by the General Statues of North Carolina, including motor vehicle insurance in amounts not less than statutory limits.

### 4.0 CANCELLATION:

- 4.1 Each certificate of insurance shall bear the provision that the policy cannot be altered or canceled in less than ten (10) days after mailing written notice to the assured of such alteration or cancellation, sent registered mail.
- 4.2 The contractor shall furnish the owner with satisfactory proof of insurance required before written approval of such insurance is granted by the owner.

It is the policy of the City of Greenville and Greenville Utilities Commission to provide minorities and women equal opportunity for participating in all aspects of the City's and Utilities' contracting and procurement programs, including but not limited to, construction projects, supplies and materials purchases, and professional and personal service contracts.

### Goals and Good Faith Efforts

Bidders shall submit MWBE information with their bids on the forms provided. This information will be subject to verification by the City prior to contract award. As of July 1, 2009, contractors, subcontractors, suppliers, service providers, or MWBE members of joint ventures intended to satisfy City MWBE goals shall be certified by the NC Office of Historically Underutilized Businesses (NC HUB) only. Firms qualifying as "WBE" for City's goals must be designated as a "women-owned business" by the HUB Office. Firms qualifying as "MBE" for the City's goals must be certified in one of the other categories (i.e.: Black, Hispanic, Asian American, American Indian, Disabled, or Socially and Economically Disadvantaged). Those firms who are certified as both a "WBE" and "MBE" may only satisfy the "MBE" requirement. Each goal must be met separately. Exceeding one goal does not satisfy requirements for the other. The MWBE's listed by the Contractor on the Identification of Minority/Women Business Participation which are determined by the City to be certified shall perform the work and supply the materials for which they are listed unless the Contractors receive <u>prior authorization</u> from the City to perform the work with other forces or to obtain materials from other sources. A finding by the City that any information submitted (either prior to award of the contract or during the performance of the contract) is inaccurate, false, or incomplete, shall also constitute a breach of the contract. Any such breach may result in termination of the contract in accordance with the termination provisions contained in the contract. It shall be solely at the option of the City whether to terminate the contract for breach or not. In determining whether a contractor has made Good Faith Efforts, the CITY will evaluate all efforts made by the Contractor and will determine compliance in regard to quantity, intensity, and results of these efforts.
