Clarifications & Requirements

- 1. Acknowledgement of all addenda received must be noted on the bid submittal form. Any and all addenda shall become part of the specifications and the bid package for the project.
- 2. All existing curbs, asphalt, concrete, landscaping, etc. must be protected or repaired to current conditions at the end of the project if damaged by the contractor.
- 3. After the existing units have been removed, the Contractor is to dispose of them properly.
- 4. Install new wire mesh under the new units to the roof deck so to keep out pigeons, other birds, etc.
- 5. Schneider Electric will be handling the connections of the existing control system to the new units. The cost of this will be the responsibility of the City of Greenville. The HVAC contractor will need to provide integration assistance as mentioned in the Scope of Work, item 1.7 on page 3 of the bid package.

Bids are due Wednesday, January 27, 2016 at the Public Works Building, 1500 Beatty Street, Greenville, NC. Bids will be accepted up to 2:00 P.M. Bids will be opened read aloud and a bid tabulation sheet will be available upon request once the contract is awarded to the successful bidder. *Note: Mailed proposals will be accepted up to the 2:00 P.M. deadline. All proposals received in the mail will be stamped with the date and time or receipt.*
