- 5. Delete the information in Section 2.7; Page 4 of the bid document and replace it with the following: *If needed, the Contractor must complete a new vendor application and all associated documents.*
- 6. The exterior portion of the chimney has already been removed. Delete any reference to the removal of the exterior portion of the chimney that may be in the specification and environmental assessment.

Bids are due Thursday, February 4, 2016 at the Public Works Building, 1500 Beatty Street, Greenville, NC. Bids will be accepted up to 2:00 P.M. Bids will be opened and read aloud and a bid tabulation sheet will be available upon request once the contract is awarded to the successful bidder. *Note: Mailed proposals will be accepted up to the 2:00 P.M. deadline. All proposals received in the mail will be stamped with the date and time or receipt.*
