HISTORIC PRESERVATION AWARDS

AWARD CATEGORIES

The **Sallie Southall Cotten Award** is conferred on women who have made important contributions to historic preservation in Greenville.

Born in Virginia in 1846, Sallie Southall Cotten was educated in North Carolina and lived most of her life in the Greenville area. A leader in the women's movement, Mrs. Cotten helped found the North Carolina Federation of Women's Clubs; was a participant in the National Congress of Mothers; and in 1899 founded Greenville's End of the Century Club.

The **Robert Lee Humber Award** is conferred on professionals or organizations that have contributed to historic preservation in Greenville.

A renowned scholar, Dr. Humber held degrees from Wake Forest College and Harvard University and was a Rhodes Scholar. After spending much of his adult life in Paris, Dr. Humber returned to Greenville in 1940, where he established the Movement for World Federation and the State Museum of Art. Active in historic preservation, Dr. Humber was a charter member of the North Carolina Society for the Preservation of Antiquities, first life member of the North Carolina Literary & Historical Association, and President (1964-68) of the Pitt County Historical Association.

The Architectural Award for Restoration Excellence is awarded to individuals, organizations, or companies responsible for the significant restoration of a residential or commercial building. In past years, the Award has celebrated the restoration of cherished local landmarks Globe Hardware and the Moye House. The City of Greenville owes a debt of gratitude to those who have expended the money, effort, and perseverance to refurbish the city's architectural gems.

The **Stewardship Award for Preservation Commitment** is awarded to individuals, organizations, or companies that have made a commitment to maintaining the long-term vitality and architectural character of historic buildings in the City of Greenville. The Award is in recognition of those quiet, steady stewards who look after Greenville's precious historic resources on a yearly basis.

ELIGIBILITY

Preservation by any individual, organization, or company whose approach is consistent with the programs and policies of the Historic Preservation Commission is eligible for a Historic Preservation Award.

Nominees must meet the award criteria as stipulated in the award description.

Nominated individuals are not required to be residents of the City of Greenville; but must have made an impact on preservation within the city limits.

Nominations may be made without the knowledge of the nominee. Self-nominations are accepted.

Previous award winners are eligible for new, completed projects that were not previously recognized by the HPC.

Current Historic Preservation Commission members or staff are not eligible for awards.
