Elizabeth Blount took roll and Chairman Johnson confirmed that the CAC had a quorum.

She also provided a list of commission members for updating and reminded the commission about the Open Meeting policy.

Ms. Keith announced the North Carolina Community Partnership's Community Garden Conference on April 22 & 23.

CONTINUED BUSINESS

Bylaws Review

Chairman Johnson decided to delay the bylaws review until the next meeting.

NEW BUSINESS

Neighborhood Improvement Grants

Ms. Keith presented the overview and criteria for the grants. She stated that the annual budget is \$6,500 per year that begins July 1. There is no rule that states only four \$750 awards can be awarded per cycle. The applications have to meet the minimum requirements before being presented to the commission. There is no limit on the number of awards that can be presented; however, the commission cannot exceed its budgeted amount. The commission has not approved any grants this fiscal year and funds are not carried over.

She presented the following:

1. Cherry Oaks North - \$750 for landscaping

Motion was made by Mr. Beeson and seconded by Ms. Gonzalez to approve the application for Cherry Oaks North. Motion carried unanimously.

2. Hopkins Park, Kearney Park and Newtown -\$600 each for community gardens

The commission noted that the estimates provided totaled \$598.97. Motion was made by Ms. Gonzalez and seconded by Mr. Beeson to approve the applications for \$598.97 for each housing area. Motion carried unanimously.

Community Appearance Award Nominations

Chairman Johnson requested votes and the nominees with the most number of votes for April was selected: Alice Keene Park, 4561 County Home Road and Rucker Johns, 4001 S Memorial Drive. Chairman Johnson volunteered to take the sign, the certificate and letter to Rucker Johns and to pick it up before the next Commission meeting.
