BALLFIELD FENCE REPAIR & REPLACEMENT THOMAS FOREMAN PARK INSTRUCTIONS TO BIDDERS

The person firm or corporation making a proposal shall submit in a sealed envelope to *Mike Watson*, *Parks Coordinator*, at the Jaycee Park Administrative offices located at 2000 Cedar Lane, Greenville N.C., 27835, on or before the hour and day stated on the attached bid request form. The words <u>Bids Enclosed</u>, <u>Ballfield Fence Repair - TFP</u> and the name <u>Mike Watson</u> should appear on the outside of the sealed envelope. The estimate may also be mailed but must be received prior to the time and date stated on the attached bid request form.

All bids will be marked with the date and time they are received by reception staff. Bids will not be opened and read aloud. Bids will be opened and evaluated and a bid tabulation will be available upon request once the contract is awarded to the successful bidder.

The bidder shall insert the required responses and supply all the information as indicated on the Bid Form. The prices inserted shall be net and shall be the full cost including all factors whatsoever. Any bids not submitted on such forms provided will be considered unresponsive.

No bid may be changed or withdrawn after the time of the bid opening. Any modifications or withdrawals requested before this time shall be acceptable only when such request in writing is made to *Mike Watson*, *Parks Coordinator*.

The City of Greenville reserves the right to reject any and all bids, to waive any formalities, and to accept the bid or any portion thereof that is deemed most advantageous to the City. Any bid submitted will be binding for 60 days after the of the bid opening.

The scope of work attached represents the minimum specification or description of work to be purchased or contracted. These requirements are not intended to prevent fair responses or to eliminate competition, but they are intended for the protection of each and every bidder to insure, if possible, that all bids submitted shall be upon a fair and comparable basis.

It is expressly understood by the bidders that written notice of award and/or receipt of purchase order will constitute agreement by the City to consummate the transaction and will serve together with the proposal, scope of work, and these instructions as the entire form of contract between the parties except in cases where formal contracts are warranted.

Bid shall be FOB, Greenville, N.C.

Each bidder shall affirm that no official or employee of the City of Greenville is directly or indirectly interested in this proposal for any reason of personal gain.

Minority and/or Women Business Enterprise (MWBE) Program:

It is the policy of the City of Greenville to provide minorities and women equal opportunity for participating in all aspects of the City's contracting and procurement programs, including but not limited to, construction projects, supplies and materials purchases, and professional and personal service contracts. In accordance with this policy, the City has adopted a Minority and Women Business Enterprise (M/WBE) Plan and subsequent program, outlining verifiable goals.

Insurance certificates and/or a copy of business license will be required if requested once contract is awarded.

Scope of Work

Scope

Provide labor and material to repair the existing fence framing, gates and for the reattaching of any loose fence fabric. Replace the existing fence fabric around the bullpens, dugout, outfield and backstop as specified.

Demolition

Remove the existing fence fabric as directed and dispose of properly offsite.

Material/Installation

- 1. Contractor is responsible for verifying all measurements.
- 2. Furnish and install approximately 490' of 4' high outfield fence fabric. Fabric shall be 9 gauge galvanized with 2" mesh. The existing poly-cap is to be reinstalled.
- 3. Furnish and install approximately 450' of 6' high bullpen and dugout fence fabric. Fabric shall be 9 gauge galvanized with 2" mesh.
- 4. Furnish and install approximately 140' of 10' high backstop fence fabric. Fabric shall be 6 gauge galvanized with 2" mesh. The existing PVC ball drop shall be reinstalled.
- 5. Tension wire (6 gauge) shall be installed at the bottom of all fence fabric.
- 6. Fence shall be knuckled at the top and bottom.
- 7. All fence ties shall be steel.
- 8. All rusted welded joints and fence rails shall be painted with galvanized paint to match the existing finish.
- 9. The repairing of all gates shall be included. Provide new fence fabric for each to match the adjacent fence. Adjust as needed so all gates swing and latch properly. Replace all rusted bolts or hardware with new as needed.
- 10. Contractor shall be responsible for providing a safe work site at all times.
- 11. All areas of work shall cleaned up and any material will need to be out of the way after work is completed for the day.
- 12. The work is scheduled to begin the first week of November and shall be completed by the end of November.

Warranty

Provide a standard manufacturer's warranty on all material and a minimum two (2) year labor warranty.
