Purpose of Meeting: Pre-bid conference

Requirements for Bid:

- 1.All contractors must be properly licensed under the State Laws governing their respective trades.
- 2.All contractors are advised that the Owner has a minority and women participation policy for construction projects. Refer to the specifications for a detailed description of this policy.
- 3. Each proposal shall be accompanied by a cash deposit or a certified check drawn on some bank or trust company insured by the Federal Deposit Insurance Corporation, of an amount equal to not less than 5 percent of the proposal. In lieu thereof a bidder may offer a bid bond of 5 percent of the bid executed by a surety company licensed under the Laws of North Carolina to execute such bond conditioned that the surety will upon demand forthwith make payment to the obligee upon said bond if the bidder fails to execute the contract in accordance with the bid bond, and upon

failure to forthwith make payment, the surety shall pay to the obligee an amount equal to double the amount of said bond. Said deposits shall be retained by the Owner as liquidated damages in event of failure of the successful bidder to execute the contract within ten days after the award or to give satisfactory surety as required by law.

- 4. Performance and Payment Bond will be required for one hundred percent (100%) of the contract price.
- 5. A contractor Reference Form, listing 3 client references of similar work is required.
- 6. A mandatory site visit is required.
- 7. Adhere to the procedure described in section 00231 Product Substitutions During Bid

Minority and Women Business Enterprise Plan Special Provisions

- 1. Each Bidder must comply with the City of Greenville's Minority and Women Business Enterprise Plan see the specifications for the requirements.
- 2. The bidder must provide the completed required MBE-WBE forms with their bid.

General On-Site Conditions

- No permanent dumpster will be allowed on site. A daily use area is designated on sheet A1.1.
 Contractor shall employ weighted stanchions and rope or plastic tape to enclose laydown area.
 - a. A trash chute may be located above this daily use area for duration of project.
 - b. Materials shall be staged for construction on the roof and shall be dispersed on the roof so that the weight of materials and equipment on the roof does not exceed the allowable roof live load of 20 lbs/sf.
 - c. Contractor shall provide roof access from this area. Contractor will not be able to use existing internal roof access during construction.
- 2. Contractor will not have access to interior of the existing building at any time.
- 3. Contractor shall provide portable toilet in location near the building generator as coordinated with owner.
- 4. Contractor will be able to use existing electrical power by connecting to existing exterior outlets as coordinated with owner.
- 5. The contractor cannot close any of the surrounding streets at any time.
- 6. Hours during which work shall be accomplished are 7:00 am to 5:00 pm Monday thru Friday.
- 7. Work at other times will require Owner approval in writing.
- 8. All existing concrete or asphalt pavement shall be repaired as necessary to return to current condition at the end of the project.
- 9. All damaged landscaping shall be replaced with landscaping of matching type and size of what was damaged.
- 10. No smoking, alcohol, or firearms will be allowed for construction related personnel on the project site.

Project Review

- A. Without force and effect upon the work defined and required by the project manual and drawings, the project involves removal of existing roof and substrates down to roof deck and replacement with new roof, substrates, and insulation including work indicated for roofing of back side and top of parapet walls. The project also involves a partial removal of portions of existing roof where indicated on drawings and provision of new roof membrane and substrate over existing remaining roof and replacement of removed roof assembly with new roof assembly as indicated. The addition of one OSHA compliant roof guardrail is also included.
- B. A 20 year roofing system warranty is required. See specifications for details.

Alternates:

- A. Alternate No.1: Provide new coping throughout to match existing and as specified.
- B. Alternate No. 2 Provide new 60 mil fully adhered black EPDM membrane as manufactured by Firestone or Carlisle in lieu of TPO membrane indicated for base bid.

TimeLine

- The duration of the project is 120 consecutive calendar days after which liquidated damages will apply in the amount of \$300 per calendar day until project achieves substantial completion.


