Q: Per page 4, 7. EEO Clause - Can the City please forward the actual clause so bidder can verify its capabilities to comply?

A:

Statement of Policy

Q: Per page 5, 8. MWBE Program: The stated goal is 2% for M/WBE and WBE; is this a requirement or only a stated goal?

A: This is a goal – not a quota.

Q: Please verify the only two items to be submitted with this bid that are Attachment A - Bid Price Form and Attachment B - Signature Form **A: Correct.**

Q: Please confirm that you are asking to leave a truck or portable tank on site during emergencies? A: Yes we would like that to be part of this bid. We have selected two location in the city so it may be two location depending on the severity of the emergencies.

Q: Under section 3.4 – Delivery you state "Delivery of fuel under emergency conditions to the city, will be agreed upon by the city and vendor at the time email is sent." Does this mean that the price to deliver a tank or leave a tankwagon on site will be negotiated if and when the need arises?
A: No. This section is referring to delivery time. We would expect that moving tanks and other equipment necessary to operate the tanks is part of this bid price structure.

Q: Who is the incumbent supplier?

A: We have not bid this contract before. We currently do spot purchasing.

Q: Please provide an invoice for both transport and tankwagon deliveries.

A: We do not have one. We currently do spot purchasing.

Q: Please provide a bill of lading each product.

A: We do not have one. We currently do spot purchasing.

Q: Please provide bid tabulations from the last time this was bid.

A: We do not have one. We currently do spot purchasing

Q: Is cost winter additive a factor in award?

A: No, we do not want winter additive.

Q: Do you use winter additive for a set period of time? (e.g. November-February)?

A: No, we do not use winter additive.

Q: Will a 24 hour delivery turnaround be acceptable?

A: Yes

Q: You state that rebates shall not be included in the bid prices. Does this mean you are requesting pricing based on the OPIS end of day average net of all prompt payment discounts? A: Yes

Q: Must vendors bid on every delivery method?

A: It is our intent to award to one vendor, but we will award to the vendor(s) who provide a bid in the in the best interest of the City. Therefore, no, you are not required to bid on every delivery method.

Q: Must vendor offer price to setup a second fueling location?

A: Please refer to items requested on the bid form.

Q: Can we attend the pre-bid meeting via conference call in?

A: Yes. See Addendum #1.

Q: What is your preferred method of bid delivery (UPS, email)?

A: No preference

Q: Please confirm there is a WBE and MBE goal?

A: There is a goal of 2% MBE and 2% WBE. Please see page 5 of the bid document.

Q: What is the WBE and MBE goal if there is one?

A: Yes, we require a good faith effort to meet the goal.
