7. NEW BUSINESS

A. Greenville Area "Person to Person Healthy Hearts Program" Presentation

Christie Clark, Chair and Erin Fox, Director of Development American Heart Association

Ms. Fox gave a brief overview of the mission of the American Heart Association. She shared the following:

- The Heart Association sets the standards of care for cardiac patients at hospitals in eastern North Carolina and the training standards for CPR.
- A very high percent of the donations go to research. Locally, ECU received a 1 million dollar grant to study "*Is exercising while pregnant good for babies?*"
- The Greenville area has two fundraising events: The Kids Heart Challenge and the annual Heart Ball.
- They provide a free presentation to businesses through the Life Services Program.
- They advocate for policies and laws to improve heart health.

Ms.Clark spoke on the new initiative in the Greenville area to grow local participation in their fundraising efforts. B. Using a Neighborhood Facebook Page for Neighborhood Communication

Sharon Stang, Carolina East Neighborhood Association

Mrs. Stang shared how social media has worked well in the Belvedere, Club Pines and Westhaven neighborhoods. Long before the Nextdoor.com app, the neighborhood had a Facebook page called BCW Neighborhood Group. Will Litchfield, District 5 councilman, and the police department monitor this facebook page. An individual who had become an aggressive panhandler was arrested due to the posts on this facebook page. Mrs. Stang strongly encouraged the group to have their neighborhoods use a facebook page or the nextdoor.com app and to invite their Council person and Police Department to join.

C. Exploration of appropriate strategies to share neighborhood concerns about unfamiliar faces and unusual behavior within neighborhoods

The discussion on this topic lead a proposal to request a representative from the Greenville Police Department to give a presentation on how to handle these challenging occurrences. Ann Maxwell, Chair, will contact GPD.

D. Work Plan 2019-2020

Ann Maxwell, Chair, informed the board that due to vacancy of the Neighborhood Liaison/Ombudsman position, the formation of goals has been delayed. Chantae Gooby, Chief Planner, informed the board that the city has many applicants, but only three qualified candidates. Possible Work Plan goals discussed included:

New Neighborhood Organizing

With a concentration on West Greenville two neighborhoods have been identified: Cherry View - Charles Pace, contact person and the neighborhood across from The Dream Park - Phyllis White, contact person

Reception or Symposium to showcase the city Boards and Commissions

Ann Wall, City Manager, would like the NAB to host one of these events.

Citizens Academy

This topic is currently on hold until we get further information from the City Manager's Office.

A Jane Jacobs Walk

The idea of the NAB hosting a walk is in the preliminary stages. Discussions between, Misun Hur, Ph.d., ECU Community and Regional Planning Dept., Ann Wall, City Manager, and Ann Maxwell, NAB Chair, have occurred. Briefly the event is an opportunity to help people walk, observe, and connect with their community and environment. Another meeting on this topic Is planned. Ann Hamze, District 4, requested to attend.

Overview of all aspects of Code Enforcement

This topic was of great interest to all NAB members. Plans are in process to have a presentation from Code Enforcement at the October NAB meeting to be held in District 3. Location options included Cypress Glen and Jaycee Park auditorium.
