4. Overview of Project

- a) Bids to include all necessary labor, material (including sales tax), equipment, supervision, etc.
- b) The directional bore conduit shall be a continuous section via role and not individual 10-foot sections.
- c) The directorial bore slurry is expected to be removed from the site. Contractor is required to restore the site back to its original condition.
- d) Contractor is responsible for field locating all underground utilities.

5. Site Requirements

- a) Access in, out, and around buildings shall be maintained at all times. This includes all corridors, hallways, sidewalks, walkways, door openings, gates, driveways, streets, etc.
- b) Construction noise shall be kept to a minimum.
- c) Temporary construction fencing is required.
- d) Contractor will be required to provide erosion control during construction.
- e) Provide tree protection during construction.

6. Submittals

a) Submittals will be required. PDFs copies will be allowed.

7. Other / Miscellaneous

a) Permit will be required from this project. Permits will be at no cost.
