

**SECOND AMENDMENT TO  
THIRD PROCLAMATION OF EMERGENCY—COVID-19  
MAYOR OF GREENVILLE**

**WHEREAS**, the Proclamation entitled “Third Proclamation of Emergency—COVID-19 Mayor of Greenville” is still in effect, and remains in effect, except for the revisions below; and

**WHEREAS**, an Amendment to the Third Proclamation of Emergency—COVID-19 Mayor of Greenville was issued on March 29, 2020 at 3:53 p.m. by the Mayor of the City of Greenville but included an inadvertent error and needs further clarification.

**NOW THEREFORE BE IT FURTHER ORDAINED THAT:**

**Section I.** The Mayor of the City of Greenville issued the Third Proclamation of Emergency—COVID-19 Mayor of Greenville (“Third Proclamation”) on March 25, 2020, which went into effect at 5:00 p.m. on March, 26, 2020. That Proclamation is still in effect.

**Section II.** The Amendment to Third Proclamation—COVID-19 Mayor of Greenville issued by the Mayor of the City of Greenville on March 29, 2020 at 3:53 p.m. is hereby repealed.

**Section III.** The Third Proclamation of Emergency—COVID-19 Mayor of Greenville issued by the Mayor of the City of Greenville on March 25, 2020 is hereby amended by repealing and replacing paragraph 15. Social Distancing Requirements and paragraph 16. Required Measures and replacing same to read as follows:

“15. **Social Distancing Requirements.** For purposes of this Proclamation, Social Distancing Requirements includes all of the following:

- A. Maintaining at least a six (6) feet of “social distancing” from all other individuals.
- B. Washing hands with soap and water for at least 20 seconds as frequently as possible and/or using hand sanitizer.
- C. Covering coughs and/or sneezes (into the sleeve or elbow, not hands).
- D. Regularly cleaning frequently touched surfaces.
- E. Not shaking hands.

16. **Required Health and Safety Measures.** Essential Businesses and Operations and businesses engaged in Minimum Basic Operations shall abide by the herein defined Social Distancing Requirements and shall take proactive measures to ensure compliance with Social Distancing Requirements, including all of the following:

A. **Reduced Occupancy in Essential Businesses and Operations.** When opened to the public, the total occupancy in any business, at any one time is limited to the lesser of the following:

- 1) Fifty (50) persons or
- 2) One (1) person per 200 square feet.

This requirement shall only apply to an Essential Business and Operation when the floor area of such business exceeds 50,000 square feet. The term “total occupancy” does not include employees of the business or any general contractors present inside the business.

B. **Compliance Checks.** An employee or employees of the business are responsible for counting the number of customers entering and exiting the store, recording the number in a ledger, enforcing the Reduced Occupancy in the Essential Businesses and Operations provision above, and, upon request by a member of the Greenville Police Department, allow the member of the Greenville Police Department to inspect the ledger and otherwise ensure compliance with this requirement and all other requirements established in this section entitled Required Health and Safety Measures.

C. **Delineated Six (6) Foot Distances.** Designate, delineate, and define with signage, tape, and/or by other physical means and control measures, consistent six (6) foot spacing for employees and customers during periods of shopping and in check-out line(s) so as to adequately maintain appropriate Social Distancing Requirements.

D. **Restrooms, Hand Sanitizer, Sanitizing Products, Portable Handwashing Stations.** Have readily available and in adequate supply for both employees and customers all of the following:

- 1) Restrooms with soap and warm water for handwashing purposes; toilet paper and flushable toilets; and lined trashcans.
- 2) Hand sanitizer containing at least 60% alcohol at separate locations other than restrooms.
- 3) Sanitizing products such as hand-sanitizing wipes and/or portable handwashing stations with soap and water.

E. **Online and Remote Access.** Post online whether a facility is open and how best to reach the facility and continue services by phone, online, or other

remote purchase. Larger Essential Businesses and Operations (those with greater than 25,000 square feet) such as Hardware and Supply Stores, Stores that Sell Groceries and Medicine, and Supplies for Essential Business and Operations, are encouraged to offer pickup and/or delivery options.

- F. **Shopping Cart Cleaning.** Designate an employee to wipe down and adequately sanitize all shopping baskets and bins and all electric, motorized, or human powered shopping carts and to be provided to customers while also allowing customers to wipe down shopping carts and baskets separately.
- G. **Check-Out Area Cleaning Procedure.** The business shall ensure that the following areas are clean and sanitized on a frequent basis, or at a minimum, at the beginning and end of each employee's shift: the bagging station, scanning scales, credit card reader, keyboards, electronic pens and any similar or related areas.
- H. **Posting of Signs.** Allow the prominent posting of signs by the City related to this Proclamation and to educate the public and to also prominently post signs:
  - 1) Encouraging customers to leave immediately if they begin to show symptoms of illness, COVID-19.
  - 2) Directing customers and to limiting bottlenecks/encouraging flow in high-density areas of stores."

This Second Amendment to the Third Proclamation shall be effective at 5:00 p.m. on March, 30, 2020, and shall remain in effect until terminated as provided in the Third Proclamation.
