Zoning Ordinance Amendment – Public Hearing Was Held on February 10, 2005

3. Consideration of an ordinance (requested by the Planning and Community Development Department) to amend the sign regulations to include reference to the standards applicable to the class of signs entitled "signs not requiring permits" and to include criteria concerning the maximum dimension of balloons and the method of attachment and display of temporary "roof-mounted inflatable balloons." The Planning and Zoning Commission at its January 18, 2005 meeting voted to <u>approve</u> the request.
