OBJECTIVE:

This is a request for information only and does not constitute a commitment implied or otherwise, that The City of Greenville will initiate a procurement action in this matter. Further, the City of Greenville will not be responsible for any cost incurred by responders in furnishing any information.

This Request for Information (RFI) is being issued to conduct market research to identify firms capable of providing a body worn camera (BWC) system including a camera and dash camera. The information collected through this RFI may be used by the City to develop future solicitations(s) for "Body Worn Camera System (BWC) and Dash Cameras".

OVERVIEW:

The Greenville Police Department (GPD) is in search of a body worn camera (BWC) system including a camera and dash camera and a digital file management system for the associated audio/video (a/v) files, installation services, and maintenance, that will allow for the capture and preservation of interactions between police officers and the public. Critical to the project is to minimally impact officers' time required for entering data into the system related to an event type or case number, and the time required to transfer digital files from the BWC to the a/v management system.

REQUESTED INFORMATION:

The RFI should specifically address the following items:

- 1. Company history/background.
- 2. Customer base you currently support. Customer references would be appreciated as well.
- 3. Describe your company's most recent efforts that have distinguished your product from other suppliers.
- 4. Affirm your ability to meet or exceed the specifications listed below.
- 5. Provide list of infrastructure needs, storage recommendations, training options, and implementation outline.

Body Worn Camera (BWC) Specs:

- Must integrate with the Dash Camera, CAD, and RMS for tagging and labeling videos
- Interchangeable batteries
- In Car Charger for the BWC
- Multiple holders/mounts for the BWC
- BWC acts as the Mic for the Dash Camera system
- BWC can be activated automatically via the dash camera, CAD dispatch, or some type of remote activation.

- Battery must last longer than 12 hours
- Smartphones App compatible with Android and Apple
- Electronic transfer of videos and footage
- Case management for investigations
- Video enhancement features such as transcription, snapshots, and redaction
- HD Videos
- Wireless uploading
- Multi-bay docking stations
- Fast charging options/wireless charging options
- Hands-Off approach to video recording, tagging, downloading
