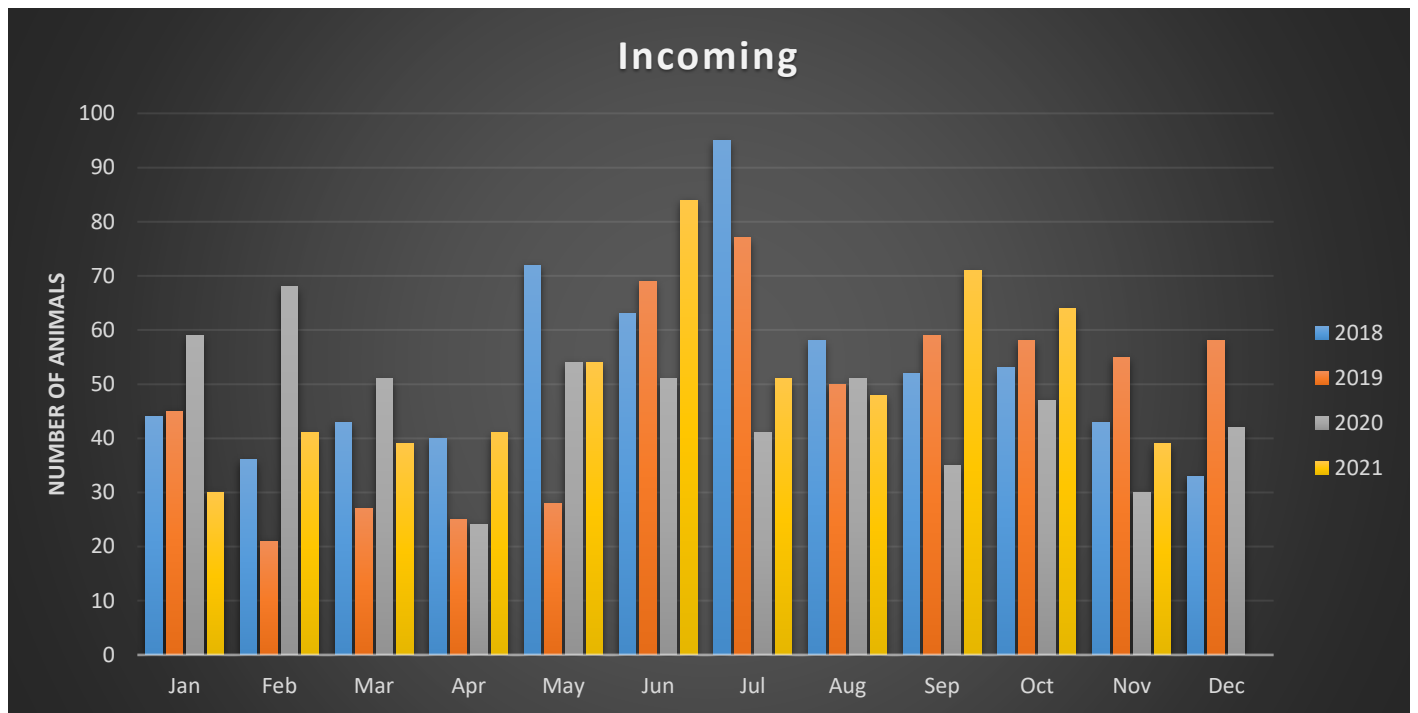
### **Mission Statement**

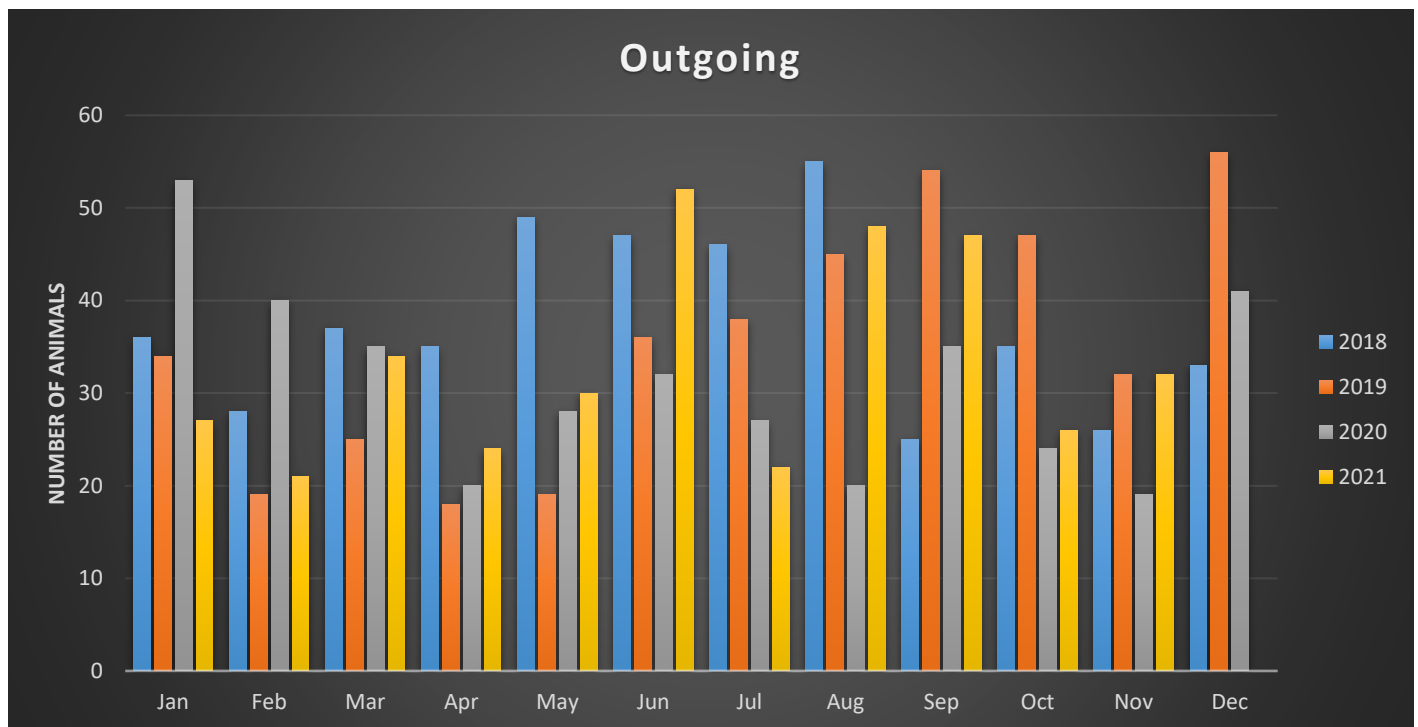
## Incoming Animals Monthly Comparison

Incoming animals include all animals that enter the custody of the Division through pickup by an APS officer or Police Officer.



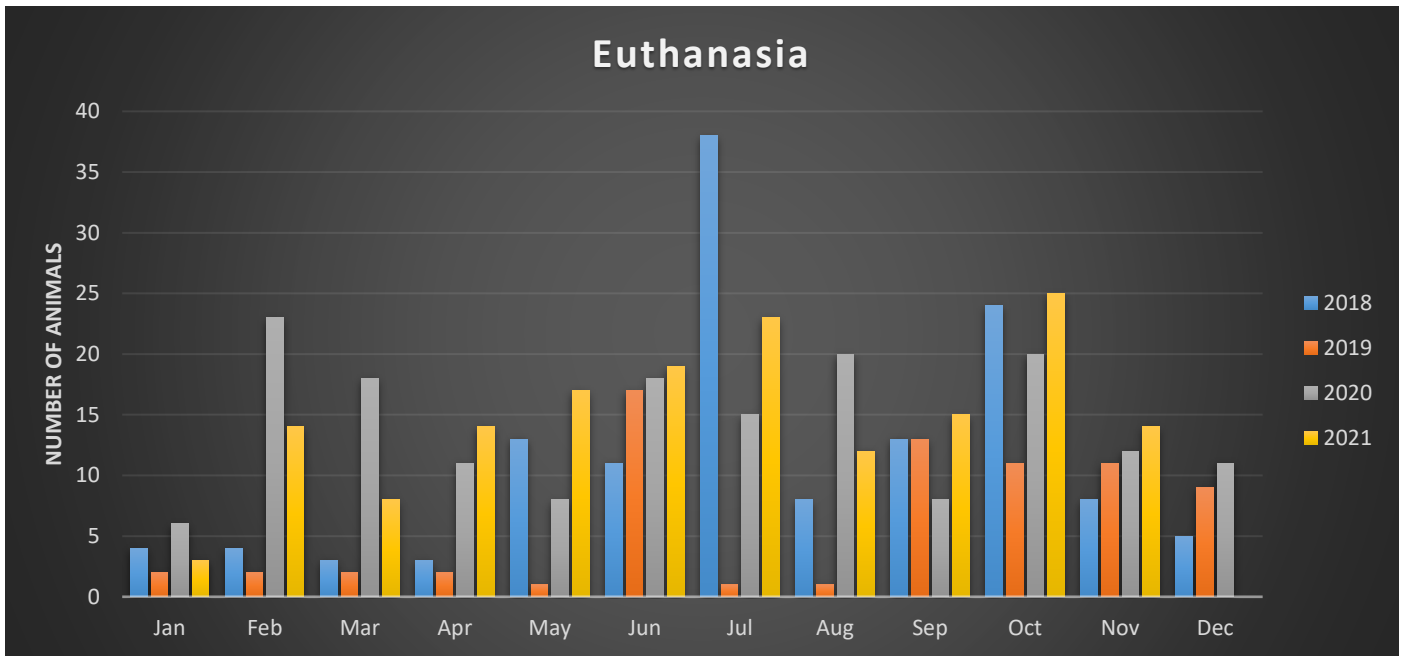
## Outgoing Animals Monthly Comparison

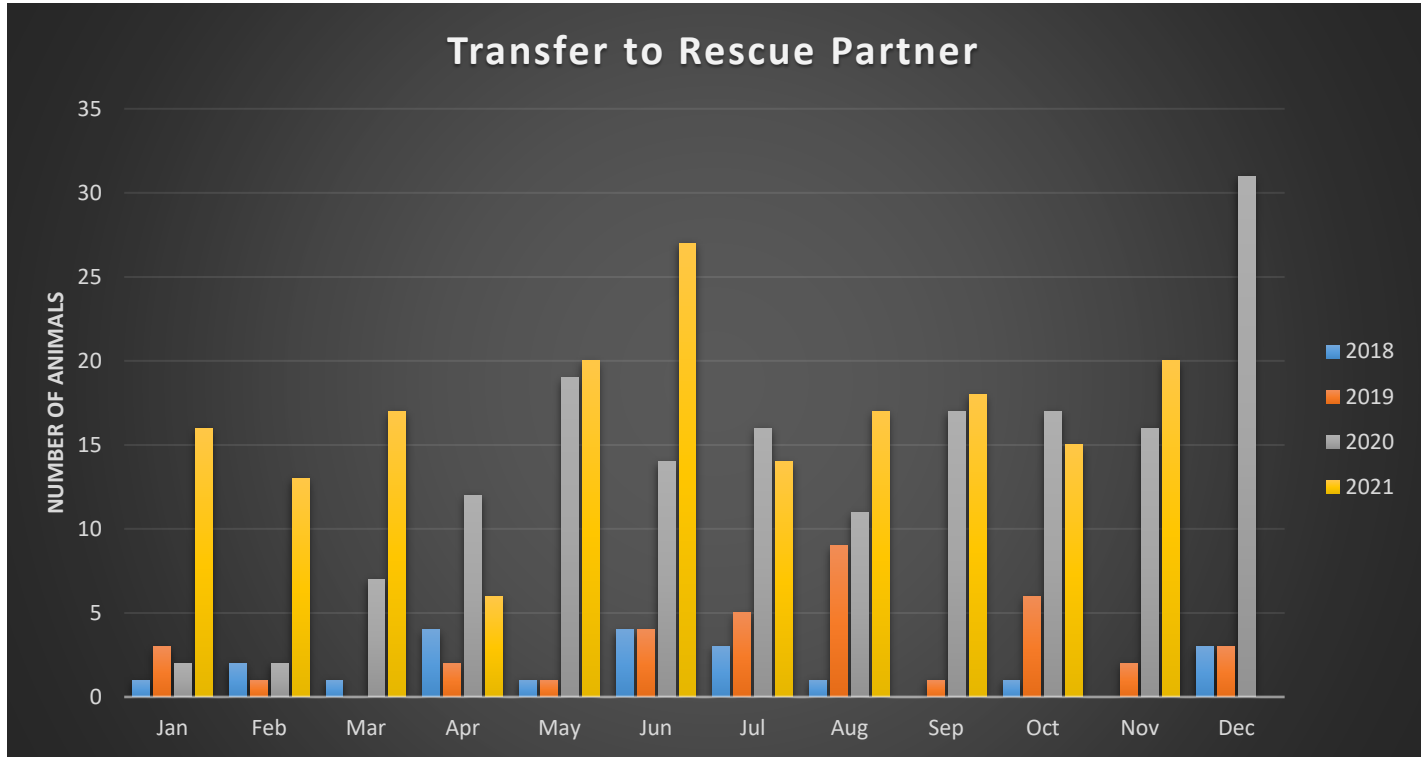
