#### PUBLIC COMMENT RULES AND PROCEDURES

- 1. An individual wishing to address the Commission during the Public Comment Period shall register electronically in the above mentioned fashion prior to the opening of the meeting.
- 2. The Public Comment Period shall not exceed a total of thirty minutes, unless the Commission, by majority vote, extends this limit.
- 3. Each individual will be allowed no more than three minutes for comments, unless the Commission, by a majority vote, extends this time.
- 4. Any item which is the subject of a public hearing conducted at the same meeting shall not be discussed during the Public Comment Period.
- 5. If the thirty minutes allocated to the Public Comment Period has not expired after the individuals who have registered have spoken, individuals who have failed to register before the meeting may speak during this comment period and will speak following those who have registered in advance. If time remains the Chair will ask if any other individuals desire to address the Commission during this comment period. An individual wishing to speak shall raise his or her hand to ask to be recognized by the Chair. After being recognized by the Chair, the individual shall state his or her name, address and the topic to be addressed. If permitted to speak, the individual shall limit his or her comments to the same three minutes limit.
- 6. The Chair shall act as official timekeeper. When an individual has thirty seconds left in their time to speak, the Chair will state "Thirty Seconds." The individual will need to bring their comments to a close. When time expires, the Chair will announce "Time Up." At that point, the individual must stop talking and return to their seat or leave the meeting room. No additional comments will be permitted or accepted once time has expired.
- 7. No action will be taken on matters raised during the Public Comment Period. If matters discussed require action by the Commission, the Chair will request staff to review and provide a recommendation at the next meeting.

City Attorney Dene' Alexander read the following statement:

Pursuant to North Carolina General Statute 160A-388 and Section 4, H. of the Historic Preservation Commission's Rules of Procedure:

H. <u>Conflict of Interest</u>. No member of the Historic Preservation Commission shall participate in either the discussion or vote on any certificate of appropriateness in any manner that would violate the affected persons' constitutional right to a fair and impartial decision maker. Prohibited conflicts include but are not limited to a member having a fixed opinion prior to hearing the matter and not willing to consider changing his or her mind; <u>undisclosed ex parte</u> communications with the person before the Commission, any witnesses, staff or other Commission members; a close familial, business or other associational relationship with the affected person; or a financial interest in the outcome of the matter before the board. On any other matter before the Commission where such decision by the Commission shall be in an advisory capacity only, no member shall participate in the discussion or vote on such advisory matters where the outcome on the matter being considered is reasonably likely to have a direct, substantial, and readily identifiable financial impact on the member. Decisions on either a request for recusal by a member or objections by a person appearing before the board shall be decided by a simple majority vote. A member so disqualified will not be counted or included in the count to determine the appropriate voting majority for the issue before the Commission and will not negate a quorum of the Commission.

#### 3. African American Cultural Heritage Action Fund 2022 Letter of Intent Update

Mr. Parker stated that on January 11, 2022, the HPC held a Special Call Meeting to consider the writing a Letter of Intent for and applying for a grant from the African American Cultural Heritage Action Fund 2022. The vote was unanimous for approval. The grant funds are to be used for the construction of a memorial wall at the Brown Hill Cemetery. Members Candy Pearce and Scott Wells volunteered to prepare and write the Letter of Intent, which they did. The Letter of Intent was signed by Ann Wall on behalf of the HPC and was submitted on Friday, January 14, 2022.

#### 4. Code enforcement report

Tony Parker presented the code enforcement cases for November 17, 2021 through February 14, 2022 in the College View Historic District to the Commission.

# 5. Discussion of Public Art to be located at the former Paddock Club property on Dickinson Avenue and Columbia Avenue

Tony Parker stated that Commission Member Candace Pearce asked that staff bring this to the commission for approval. The proposed piece of public art is a sculpture designed by Greenville artist Jessica Bradsher to represent Greenville's commitment to inclusivity for all members of the community. The sculpture is proposed to be located on a piece of NCDOT residue right-of-way located on the southwest side of the 10th Street Connector, off Dickinson Avenue in the vicinity of Columbia Avenue and is where the former Paddock Club was located. At the February 7, 2022 at their workshop, City Council approved The Pitt County Arts Council and Civic Arts Committee to work with the City of Greenville's Public Works Department on the permitting process with NCDOT, including the logistics and proper process for design, placement, and implementation.

Ms. Pearce stated there needs to be a formal motion that the commission approves of the location so the Arts Council can use that for the City Council meeting.

Mr. Caspar asked what the long term use of the land will be.

- Ms. Pearce stated it will be a community gathering space, like any other park.
- Mr. Morehead asked if there is an intention to rotate pieces through the area or is this a permanent installation.
- Ms. Pearce stated there are no intentions and there are no long-range plans for this area.

Motion made by Mr. Morehead, seconded by Mr. Caspar, to support the installation of the public art. Motion passed unanimously.

#### **Abstract for the Proposed Project:**

## The East 5th Street National Register Architectural Survey and National Register Nomination

The City of Greenville proposes to hire a consultant for the proposed East 5th Street National Register Nomination which would create a new historic district resulting in six (6) national register districts in Greenville. The East 5th Street National Register Nomination is an area of 57.66 acres and will potentially add an additional 170 properties to Greenville's inventory of historic properties. The survey of the additional properties would be the first step for those properties to be listed on the National Register of Historic Places. Designation of the area will give incentives to owners of property in Greenville and open the opportunity for restoration and renovation of additional resources within the State of North Carolina.


Staff has consulted with John Wood, Regional Supervisor, on February 22, 2022 to discuss the update of the existing College View Historic District architectural survey update and potential National Register nomination and the East 5th Street National Register Architectural Survey and National Register nomination.

This area was deemed potentially eligible for National Nomination status by SHPO staff (Scott Powers, now retired) in 2020. The City has held public interest sessions and has conducted a survey of the property owners in the area. At the April 22, 2022 meeting of the Historic Preservation Commission, a resolution of support was voted on and passed. The local neighborhood association, Tar River University Neighborhood Association (TRUNA) has written a letter of support (attached).

The proposed project primarily fulfills the NC Historic Preservation Plan, 2013-2022 goals

of Identification/Designation and Advocacy and once completed, would also fulfill the Education/Technical Services goal. Identification/Designation; Identify the state's historic resources so that they become better known and understood and are incorporated into the community, regional, and state planning. Advocacy; Cultivate support for historic preservation among elected officials. Education/Technical Services; Provide timely and expert assistance on matters related to historic preservation in North Carolina.

Data collected by the consultant will be integrated with the City of Greenville's GIS system and made available to the public.

#### **Abstract for the Proposed Project:**

## College View Historic District Architectural Survey Update and National Register Nomination

The City of Greenville proposes to hire consultant for the College View Historic District (CVHD) architectural survey update and National Register nomination. The CVHD received National Register of Historic Places status on February 6, 1992, which included 256 properties. On February 10, 1994, the City of Greenville passed an ordinance designating CVHD as a local historic district.

The College View Neighborhood developed northward from East Fifth Street in a grid pattern with intersecting streets forming blocks. East Fifth Street is the southern boundary which also separates the residential neighborhood from East Carolina University's Main Campus. The growth of the neighborhood was initially stimulated by the university. The standard grid pattern of the streets reflects the community's planned development. The neighborhood was also characterized by a mixture of early twentieth- century architectural styles that include American Craftsman, Tudor, Colonial Revival, and a few others. All houses were oriented toward the street with side driveways leading to garages placed in the rear of the lot.


The original survey was conducted in 1991 and the period of significance was 1910-1941. From the original survey, 51 parcels were considered non-contributing. All of these structures will probably age in with the new established period of significance between 1910 and 1972. The survey of the properties beyond the current CVHD borders will expand the area north to 1<sup>st</sup> Street, east to Elm Street, west to the Town 1161956

Creek Culvert, and will continue to fill in south to 5<sup>th</sup> Street. This project will identify the historic growth of the neighborhood and will add several properties to the National Register.

Staff has consulted with John Wood, Regional Supervisor, on February 22, 2022 to discuss the update of the existing College View Historic District architectural survey update and potential National Register nomination. The project will be in an area containing 125.98 acres. The City has held public interest sessions and has conducted a survey of the property owners in the area. At the April 22, 2022 meeting of the Historic Preservation Commission, a resolution of support was voted on and passed. The local neighborhood association, Tar River University Neighborhood Association (TRUNA) has written a letter of support (attached).

The proposed projects primarily fulfills the NC Historic Preservation Plan, 2013-2022 goals of Identification/Designation and Advocacy and once completed, would also fulfill the Education/Technical Services goal. Identification/Designation; Identify the state's historic resources so that they become better known and understood and are incorporated into the community, regional, and state planning. Advocacy; Cultivate support for historic preservation among elected officials. Education/Technical Services; Provide timely and expert assistance on matters related to historic preservation in North Carolina.

Data collected by the consultant will be integrated with the City of Greenville's GIS system and made available to the public.
