# During the past few months, Our Code Enforcement Division encountered a few unique minimum housing code cases that required detailed enforcement actions. During the enforcement actions of these cases, it became apparent that our City's ordinance as well as our policies and procedures, etc., needed to be updated. It has been many years since an update on this section was undertaken. A few examples of the necessary updates include: new and expanded/refined definitions, re-ordering of a few section titles, edits and expansion of our

Title 9, Chapter 1 of the City's ordinance also includes the Building & Inspections Division. That portion too has not been reviewed/revised in many years. As such, since both divisions are responsible to follow specific enforcement regulations, work is underway to review and update all procedures and processes outlined in the ordinance. We are taking this time to let you know we are conducting an in-house review of the subject ordinances, and will be bringing proposed changes to council in the future for your consideration. Our expectation at this time would be to bring them to you within three to four months. During this time we will also look to hold informational stakeholder meetings with our area property management groups and any interested individuals that may choose to attend.

Our office will be working closely with our City Attorney's office to ensure any changes proposed are in line with regulatory requirements and procedures. Please let us know if you have any questions regarding our goal of updating these selected ordinance sections (Title 9 Chapter 1) as well as our internal policies and procedures.
