We are pleased to inform you of the hiring of our new MWBE Coordinator, Tish Williams. Tish started with us in Purchasing on February 14, 2022. She previously worked for the Wayne County Board of Education as an Office Manager/Board Specialist for six years before joining us. Since the official launch in January 2021, Incubate to Accelerate (IA), a business growth and expansion strategy for small, minority and women-owned firms continues to make some progress in its effort to provide capacity building resources and technical assistance to these firms. Provided is an update of the activities and outcomes to date.

MWBE Loan Fund:

Since the last update dated September, 13, 2021, MWBE has received one application for \$25,000. The application is currently in underwriting. To date, the program has awarded \$50,000 in financial assistance to MWBE firms through the loan program.

Shared Kitchen Space:

Two small businesses have approved applications, completed orientation, obtained the necessary insurance, and are ready to sign a twelve (12) month sublease agreement starting April 1 within the City leased kitchen space at The Gold Post.

Cookin' with Carmen, LLC, owned by Chef Cierra Swain, promotes and creates African heritage cuisine using healthier alternatives with fresh ingredients. Cookin' with Carmen will offer weekly meal plans and catering service.

Subcessful, owned by Ms. Samantia Cummings, offers a small variety of Philly cheesesteak style subs and French fries with delicious toppings. Ms. Cummings is providing a meal option for lunch or dinner time and offers sub platters for large gatherings.

A third firm has submitted an application and is pending approval from Pitt County Environmental Health. Should the third firm complete the process and sign a sublease, there would be an opportunity to add one more business under this program.

Repeat Calls for Service

During the month of April, there were 60 total calls for service that triggered Mobile Crisis notification. Of those 60 calls to the police department, Mobile Crisis responded to 30 of them. Of those 30, 19 individuals were linked to services. Only two of the locations we responded to during April required more than one response. We responded several times to one of the locations and twice to the other. Mobile Crisis was able to link the repeat call subject with services in another county and we have had no other calls for service since they did so. At the other location, where we had 2 calls on the same day, we have had no other calls since April 4, 2022.

Monthly Highlights of Service Calls

- Mobile Crisis responded to a female suffering from dementia (repeat caller and location from above).
 Follow up was conducted with the individual and other agencies involved and the individual was successfully linked to placement in an Assisted Living Facility designed to treat individuals with dementia.
- Mobile Crisis responded to a minor male displaying aggression and being defiant towards parents.
 Follow up was conducted with the individual and his family have been linked to more intensive mental health services.
- Mobile Crisis responded to a minor female displaying self-injury behaviors. Follow up was conducted with the individual and her family. The individual was successfully linked to more intensive mental health services.
