Re:	NTC – Special Event Update for Wildwood Park

Following a successful summer of various program and event opportunities at Wildwood Park, staff are preparing for an eventful fall. This memo is to provide an update on some of the past programs held at Wildwood Park and those planned for the fall season.

Special Events Supervisor, Megan Howard, led the efforts on planning the departments first Active Adult & Senior Social at Wildwood Park. Held on August 29th from 9am -1pm, department staff came together to show off the programs and services currently offered at various recreation facilities. During this event, staff were able to engage 79 individual participants who had the opportunity to choose from many activities. Those included:

- o Jaycee Park Art Center staff led two paint in the park class.
- Adult Athletics and Greenville Aquatics & Fitness Center Staff led three introductory pickleball classes.

SUBJECT:	Notes to Council: Summary of Code Enforcement Ride Along with Council

Per a request from Council Member Rose Glover a ride around was scheduled On August 24th in

reference to Code Enforcement concerns. The following were in attendance during the ride-along:

During the ride along, properties of concern were discussed and some inquiries made regarding Minimum Housing violations, Public Nuisance violations, along with Junk / Nuisance / Abandoned vehicle violations.

With the current state of Code Enforcement, we shared several bits of information with Council Member Glover we feel would explain actions we plan to implement. The following are our action plans:

- <u>Abandoned / Boarded up Structures</u>: Our plan is to activate enforcement action on a compiled list of structures once we have dealt with those of a more unsafe nature. As has been done over the past several months we will present the structures to council for demolition ordinance approval.
- <u>Abandoned, Nuisance and Junk Vehicles</u>: The City has been without a towing contractor for these types of vehicles for a long while. This towing process is different than that the Police Department deals with (i.e. vehicle accidents). We are just weeks away from having proper towing contracts awarded for this service. We are actively training on the processes and procedures to take when dealing with the Abandoned, Nuisance, and Junk Vehicles and look to be able to enforce the City's ordinance fully within the aforementioned weeks.

- <u>Focus areas</u>: The Planning and Development Services Department Divisions (including Code Enforcement, Building Inspections, Planning & Zoning, and Housing) are working on a coordinated effort to actively provide enforcement actions from different fronts within noted focus areas. We intend to have a departmental ride along to get a close up look at the issues in the neighborhood and determine the best plan of action to address issues comprehensively. These areas include a section of Dickinson Avenue, Spruce / Myrtle Street, and Albemarle Avenue.
- <u>Public Nuisance and Weeded lots</u>: This is an area that seems to be a constant battle. Code often deals with vacant properties, absentee ownership, tenants that do not share the same views as are listed within the City Code of Ordinances.

At the end of the ride along, though violations were noticed, it was evident that Code Enforcement is active within the community and are making strides in positively dealing with the larger code items. There were approximately 40-45 properties pointed out by Council Member Glover and the City Manager's Office and we are having Code Officers check each one for enforcement. We will report back in approximately 4 weeks with a progress update. Code Enforcement will soon be submitting to Council the minimum housing ordinance review revisions that need to be updated.

Re:	NTC – Bradford Creek Golf Course Update	

This memo is to provide a brief update on Bradford Creek Golf Course's financials and the overall operations of the course.

Despite the course being closed 16 days due to winter weather last year, golfers continued to play the course when conditions allowed. The number of annual rounds played were less in Fiscal Year 2021-2022, compared to Fiscal Year 2020-2021. However income from Green Fees, Cart Fees, Pro Shops Sells, Annual Memberships and the Driving Range were higher than the previous year.

Annual income was approximately \$19,500 higher than the previous year, however expenses also increased. The increase in expenses was directly related to the rise in labor costs to maintain the course. These costs included the addition of a full-time Assistant Greens Superintendent, which was vacant during most of 2021, and additional seasonal help to maintain course conditions. The increase also accounted for the inflated cost of maintenance supplies such as fertilizer and other turf chemicals.

Below is an overall usage and financial breakdown, including a comparison to previous year:

Throughout Fiscal Year 2021-2022, City staff worked with Indigo Golf Partners on various initiatives to improve golf course maintenance and customer service. A few of those initiatives include:

- Addressing maintenance concerns throughout the course, including:
 - Future Fence Repair Along the Perimeter of the Course
 - o Golf Cart Path Repair on the Front Nine
 - Overall Green Conditions
 - Improvements to the Club House Entrance
 - o Over-seeding Driving Range Tee Box
 - o Various General Maintenance Items
 - Removed bushes from Driving Range
 - Continued sand bunker renovations
 - Improved stream bank landscaping
- Negotiated a New Cart Lease Set to Begin Fall of 2022.
- Maintaining Inventory of Pro Shop Items

Recreation and Parks Superintendent Dennis Vestal continues to keep an open line of communication with Indigo Golf Partners staff. Mr. Vestal will continue to meet with golf course staff monthly and monitor the operations of the course. City staff will also meet with Indigo Golf Partners Management Staff quarterly to discuss golf operations and course conditions.

It remains a priority of City staff to continue to work with Indigo Golf Partners to enhance the experience of golfers at Bradford Creek Golf Course to assist with increasing the number of rounds being played monthly. There are several initiatives outlined for the next 8-12 months and staff will provide updates to Council Members throughout the year.
