### Addendum #2

- Q: Could you possibly send my company the current amounts that each of these contracts is going for now?
  - A: Current price per month is \$3,000 for contract #10.
- 2. Q: The bid package says no mowing on Sunday. Is this correct?
  - A: Mowing on Sunday will not be permitted unless circumstances, such as weather, impact normal mowing operations during Monday-Saturday. Please follow protocol in the bid package to notify in writing of any circumstances that impact normal mowing during the week. Contractor will also need to receive prior authorization from the City before mowing on Sunday will be permitted.
- 3. Q: Do we have to provide certificate of insurance (COI) as part of the bid?
  - A: COI will not be required in the bid package, however, a COI, per specifications outlined in the invitation to bid, will be required to be in place prior to award of contract.
- 4. Q: Could you provide me with maps for Contract #10?
  - A: The maps for Contract #10 are available and these are posted on the City's bid advertisement website via addendum #1.
- 5. Q: I was wondering if there was a specific type of mulch the City wants to remulch these areas along 10th street and if ALL of the beds, even on the sides of the overpass, will be mulched?
  - A: Turf and plant beds are noted on the maps provided. Please refer to page L6 on the maps that detail the plant beds and turf locations on the sides of the overpass and maintain according to the scope of work. The mulch to be used is also specified on all of the maps, either under plant schedule notes or under general notes.
- 6. Q: What are the areas for litter pick up and are we to pick up litter in the area close to Raleigh Street?

  A: Litter pick up and removal is defined in 3.0 section 3.1 and 3.12 under <u>Litter Cleanup</u>.
- 7. Q: Are we supposed to do the upkeep on the bushes that are on the preexisting fence line that is on the right heading into the City?
  - A: Refer to maps for shrubbery that is to be maintained under this contract. Encroaching vegetation will be maintained by City of Greenville Staff.
- 8. Under 3.0 "RIGHT OF WAY LANDSCAPE MAINTENANCE" section 3.12 under builet point "Litter Cleanup" on page 8, the word "two" needs to be deleted in the last sentence.
- 9. Under 4. 0 "PAYMENT AND BID" section 4.1 on page 10, the following language needs to be added..."Upon successful completion of year one (1) of this contract, per specifications and directives, and at the written request by the Contractor at least 30 days prior to the renewal date of this contract, the Contractor may be eligible for a 3% annual increase for year two (2) and year three (3). Each request MUST be in writing and submitted at least 30 days prior to the contract renewal date for each year of the request in order to receive the 3% increase. This request for increase will be reviewed and approved by the Director of Public Works (or their Designee) and the Contractor will be notified in writing of these changes."
