### **General Questions, Clarifications & Requirements:**

1. Question: What determines an approved equal for the generator?

Answer: City Staff will review all proposals to ensure Generator Sets and Automatic Transfer Switch (ATS) meet the required specifications.

2. Question: Will the ceiling on the mezzanine remain open during construction? Answer: The ceiling on the mezzanine will remain in the current state during construction.

3. Question: What type of conduit are you specifying? Answer: Appropriately sized, mounted and terminated metal-clad (MC) cable.

4. Question: Will this project require state inspections? Answer: No. Project will require local inspections and permitting only.

5. Question: Will you specify what kind of data drops? Answer: This does not apply to this project during this phase of construction.

6. Question: Are you going to remove the lights in the ceiling on the mezzanine? **Answer: No.** 

7. Question: Will you require a fence around the generator? Answer: No. Bollards will be installed around the generator per specifications.

8. Question: If we need to relocate the fence around the parking lot, will the contractor be responsible for this cost?

Answer: City personnel will handle operations in regards to the fence.

9. Question: Will the contractor be required to move the fence to obtain 3' clearance around the ATS? **Answer: City personnel will handle operations in regards to the fence.** 

10. Question: Where will the annunciator/E-stop be located? **Answer: Adjacent to the Main Distribution Panel (MDP).** 

11. Question: Will the contractor be responsible for communicating with Greenville Utilities Commission (GUC) for power shut off and start up?

# Answer: Yes. Power shut-off and start-up will be coordinated through GUC, City of Greenville and the Contractor.

12. Question: Will the City provide restrooms? **Answer: Yes.** 

13. Question: Are there any prints and specification for this project? If so, could you please send the link?


