This update will be a summary of activities for FY 2023. The Neighborhood Advisory Board (NAB) continued to struggle making quorum. During this time the NAB met three (3) times, two (2) of these times they met without quorum (approved by Thomas Barnett, Director of Planning and Development Services). They have not met since March 16, 2023.

In April 2023, Staff conducted surveys of cities in the state to determine how those municipalities addressed community relations and neighborhoods. Staff evaluated the findings and determined:

- Greenville has a unique board; no other city has a similar board or commission that is not appointed by council, staff, or a combination of the two
- For those cities with neighborhood/community engagement boards, the members are appointed by council, staff, or a combination of the two.
- The depth of engagement is population based.

On May 13, 2023, staff sent out 187 interest letters (which included a survey link) to community members we had on file as contacts for various neighborhood associations. Of those, we had 4 survey responses, 10 email responses, and 27 letters returned by the US Postal Service. The survey indicated that 4 out of the 4 associations who responded are active. Those associations primarily use email as their communication source as well as nextdoor.com. Staff received 10 responses to the letter. Two letters were from HOA management companies, one asking we direct queries to them rather than board members, the other sent their contact information only. Four associations do not meet anymore. Three responded they meet regularly, one stated they meet as needed.

With the creation of the Neighborhood and Business Services Department, staff has discussed sun-setting the NAB and developing a new model for neighborhood engagement. Staff members of the Community Development Division met with City of Raleigh staff to seek information about their community engagement programs. Staff continues to work towards developing programs that will work best for the City of Greenville.

Police Community Relations Committee 2023 Annual Report

The Police Community Relations Committee (PCRC) was established in September 1996 to serve as the liaison between the community and police over issues of common interest. It has seven (7) City Council appointed members and two (2) ex-officio members, the Chief of Police who serves as the Staff Liaison and the Assistant City Attorney who provides legal oversight and counsel. Currently, Mr. Addison (Sonny) Bass serves as the Committee Chair and Mr. Mark Parker as the Vice-Chair. To date there is one (1) vacancy - District 2.

PCRC members continue to work diligently to stay abreast of current events, advocate for police programs, promote community safety awareness, provide citizens with educational opportunities, and provide citizens with the opportunity for public comments at each meeting, The PCRC meets monthly, with the exception of July and August. During the last twelve months the Committee met eight (8) times. A brief summary of recent meetings is attached.

Spotlight: Topical Issues and Advocacy - Non-traditional Community-based Partnerships

The Mobile Crisis Co-Responder Outreach Services Program was the subject of the April 11, 2023 community meeting. In January 2021, the Greenville Police Department (GPD) in partnership with Integrated Family Services launched the Mobile Crisis Co-Responder Program. The purpose of the program was to improve the response to calls related to suicide attempts, domestic violence, mental illness, and drug overdoses. This 24/7 initiative was a direct response to the national call for non-traditional community-based partners to deliver enhanced public safety responses to those in crisis. Mobile Crisis co-responders respond directly to the scene of mental health-related calls where they work alongside GPD officers to deliver the highest level of care possible to persons in crisis. The co-responder team members are not police officers, but specially trained mental health professionals. The Greenville Police Department was the first agency in eastern North Carolina to implement a program of this kind.

Spotlight: Community Safety Awareness and Educational Opportunities

PCRC's efforts to promote community safety awareness and provide educational opportunities were very successful again this year, as evidenced by the sixty (60) people who attended the May 9, 2023, community meeting on "Traffic Safety and the NCDOT Evans Street Widening Project" and the over thirty attendees at the "School Safety, Proactive and Reactive Response" presentation in September 2022.

The "Traffic Safety and the NCDOT Evans Street Widening Project" presentation focused on the need to increase capacity and improve traffic flow along Evans Street /Old Tar Road. The scheduled improvements are expected to increase safety along the roadway and will provide continuous designated areas for cyclists and pedestrians, thereby improving safety and promoting these alternative means of travel. The scheduled improvements will impact hundreds of citizens and will take over 3 years to implement.

The "School Safety, Proactive and Reactive Response" presentation was most opportune as schools were back in session. The discussion was lively with many questions about campus safety, emergency response and resources for students and parents.

The Police Community Relations Committee plans to continue to work formally and informally to be aware of the perspectives of the citizens of Greenville and to provide them with opportunities for discourse. PCRC members remain committed to providing quality informational/educational opportunities for the community and are looking forward to another successful year.

NTC - Bradford Creek Golf Course Update

This memo is to provide a brief update on Bradford Creek Golf Course's financials and the overall operations of the course. Despite the course being closed for 17 days due to winter weather last year, Bradford Creek Golf Course had another successful year. The number of annual rounds played and driving range usage both increased compared to last year. In addition, revenue from Green Fees and Pro Shop sales also increased.

Annual income was approximately \$125,677 higher than the previous year, however expenses also increased. The increase in expenses was directly related to the rise in labor costs to maintain the course, course supplies and the increase in cost of maintenance supplies such as fertilizer and other turf chemicals.

Below is an overall usage and financial breakdown, including a comparison to previous year:

Throughout Fiscal Year 2022-2023, City staff worked with Indigo Golf Partners on various initiatives to improve golf course maintenance and customer service. A few of those initiatives include:

- Painted Lobby in Pro shop
- Hired a vendor to provide weekly landscaping maintenance at the entrance of the course
- Future Fence Repair Along the Perimeter of the Course
- Improved Overall Green Conditions
- Over-seeding Driving Range Tee Box
- Various General Maintenance Items
- Aerated fairways

It remains a priority of City staff to continue to work with Indigo Golf Partners to enhance the experience of golfers at Bradford Creek Golf Course and share updates with the Greenville community. Recreation and Parks employees, Dennis Vestal and Courtnee McGrath, continue to keep an open line of communication with Bradford Creek staff to ensure golf course updates are routinely shared on City social media outlets.

NTC - Summer Camp and Outdoor Aquatic Center Recap

Recreation and Parks staff wrapped up a successful summer camp season on August 4, 2023. Throughout the summer, the Department's wide array of camps (day camps, art, nature and sport specific) provided opportunities for over 2,000 youth participants at multiple facilities. Campers enjoyed many different activities including field trips and experiences creating many core memories.

Along with summer camps, the Greenville Aquatics and Fitness Center had a successful summer season at the Outdoor Aquatic Center. Several Recreation and Parks summer camps visited the Outdoor Aquatic Center, where Aquatic staff also offered swim lessons, hosted swim meets, and provided public swim hours. Staff estimate a total of 16,784 individuals attended the Outdoor Aquatic Center in some capacity this summer.

With additional recruitment efforts and the Lifeguard in Training (LIT) Program, staff were able to expand operational hours compared to last summer. This summer the pool was open Memorial Day weekend through Labor Day weekend compared to last summer operations of June 4 – August 13.

To prepare for the busy pool season, Recreation & Parks staff held multiple pool registration events at Thomas Foreman Park (2), South Greenville Park (1) and Jaycee Park (1) to collect pool liability waivers and to sell summer memberships. Staff also held a lifeguard recruiting night at Eppes Recreation Center to promote summer employment opportunities to facility users.

Recreation and Parks staff are already in the planning stages of 2024 summer camps and aquatic programs. Registration for those will begin February 5, 2024 with registration taking place until each program meets its capacity. Beginning early 2024, staff will share summer opportunities via social media and other marketing methods so families can start their summer planning.


