## • Present list of Priorities to Les Robinson Dan Hemme

MTC committee presented the list that was created of the items that they would like Les Robinson to focus on with the City Council. They went through each item and discussed them. Les requested that the committee come up with an action plan for each item. It was discussed that some of the items really just needed a formal or informal resolution to be presented to the City Council. Discussion ended with Les Robinson requesting some of the items being more pointed. Especially the City Ordinances to see where things need to be changes or updated.

The updated BikePed Cost Estimation Tool has also been posted on the Prioritization Data page under P7 in the duly named folder.

- \* The tool itself is an Excel spreadsheet that can be saved locally on your own computer to be used and cleared repeatedly for multiple projects.
- \* Various supporting documents are posted, including a Quick Start Guide and a User Manual that should both be thoroughly reviewed prior to using the tool, as there are built-in assumptions, disclaimers, and tips for various project types that the user should be aware of.
- \*A short recording of a walk-through on how to use the tool is posted as well.
- 2. P7.0 Funding Availability and Projections
  In the summer of 2023, the SPOT office released the available funding for the upcoming cycle. The slides attached below describe the funding availability, as well as provide information on how GUAMPO projects are scored and programmed. The STIP office has released available funding estimates for Prioritization 7.0 are:

Statewide: \$3.94B Region B: \$34M Division 2: \$-55M

For your reference: The last Prioritization Cycle P5 the Region B was \$256.3M, that's \$222.3M less and Division 2 was \$144.6M, that's \$199.6M less. So, there is not a lot of funding for this cycle. These numbers are a snapshot in time, and they are expected to change, as we get closer to the release date for the 2026-2035 STIP. Attached below are the funding breakdown and projections for P7.0, detailing how much is available per region and division, as well as how each of the modes and projects get scored.

As a result of this information, The MPO has been working on various strategies in order to create projects that will be able to both low cost, as well as high scoring.

- 3. Greenville-Washington Greenway Feasibility Study
  The Greenville-Washington feasibility study has been
  progressing, as the consultant now has narrowed down the
  examined routes. There are now 4 major corridors in which
  the consultant is considering for the greenway connection path.
  All 4 come with their own varying degree of challenges and
  benefits.
- 4. Greenville-Raleigh Passenger Rail Study

The Rail division have a consultant scoped to start the study, but it has not started vet.

We will hear next month or in early October whether or not the corridor is picked to be included in the Federal Railroad Administration's Corridor Identification and Development Program.

The CID program will provide funding to prepare / plan a Service Development Plan and subsequently fund NEPA and associated preliminary engineering. Whether or not it is in that program will shape / increase the scope of the study and the process we will need to follow.

Until we hear from the CID program and get further along with the consultant, there is not too much to update. Because the study has not yet progressed, it was recommended for the MPO to submit projects on the corridor for STI purposes. The purpose of this would be to test the feasibility of getting the project funded through STI, while also testing out some of the changes that the Rail division had made to the rail category for Prioritization 7.0
