SUBJECT:	Notice of Award of Disaster Relief and Mitigation Fund Grant

The City has received a Notice of Award (attached) for \$1,500,000 in additional funding under the North Carolina Emergency Management (NCEM) Disaster Relief and Mitigation Fund (DRMF) to support design and construction of the Drainage Improvements and Stream Restoration at East Firetower Road project. The East Firetower Road Project involves the replacement and upsizing of culverts under East Firetower Road and uses nature-based solutions to stabilize and establish floodplain benching to lower flood risk to nearby public infrastructure and private property. A more detailed project summary is provided below.

The total estimate for the project in the City's Capital Improvement Plan (CIP) is \$18,702,270. The City was previously awarded \$9,205,611 in FEMA Building Resilient Infrastructure and Communities (BRIC) funds from the fiscal year 2022 application cycle. With the CIP and the previous BRIC grant award, \$9,496,659 from the City's local funds were committed as the local cost share. In an effort to minimize the City's financial exposure, the Engineering Department identified and applied for the DRMF Grant. The \$1,500,000 award from the DRMF grant covers some of the increased construction costs and lowers the City's local match to \$7,996,659.

PROJECT SUMMARY: The East Firetower Rd Project was identified as a priority watershed improvement project in 2016 as part of the Fork Swamp Watershed Master Plan. East Fire Tower Road is a major thoroughfare for the city with an annual average daily traffic (AADT) of 33,000. The current culvert that channels the tributary under the road is insufficiently sized and flood water overtops the roadway after a 2-year rain event. The City's stormwater models expect that the culvert will likely fail in a 50-year rain event. The proposed project will upsize the culvert at this crossing, which will allow flow from a 50-year rain event to pass without overtopping the roadway.

The project will also include 3,240 linear feet of floodplain benching along Fork Swamp Unnamed Tributary 3, and 2,000 linear feet along Fork Swamp Main Branch. Without the proposed drainage improvements and floodplain restoration, East Fire Tower Road is increasingly at risk of flooding as climate change causes more frequent and severe precipitation events in Greenville. Furthermore, the proposed floodplain improvements will mitigate flooding for 90 homes that sit in the floodplain between the two stream crossings, specifically those on Treetops Circle, East Fire Tower Road, and Summerhaven Drive. Stormwater models indicate that the project could remove 26 properties from the 100-year floodplain.
