#### Do's & Don'ts

- **Do** adhere to signs posted within the lots and on-street.
- **Don't** disregard or ignore signs posted within the lots and on-street.
- **Do** pay/ appeal citations in a timely manner.
- **Don't** disregard or ignore parking citations as additional fees will apply.

#### **Frequently Asked Questions**

- 1. What happens after my 2 hours has expired? You will need to move your vehicle to another lot to avoid a parking citation.
- 2. What are my options for parking if I work Downtown? Employers/ Employees may purchase a permit from the city that allow all day parking. For more information, please visit parking.GreenvilleNC.gov
- **3. Is there any all-day parking available Downtown?** Non-restricted parking is available on:
  - Reade street within the 100 to 300 block
  - Second and Third Streets between Cotanche and Washington Streets
  - First Street (outside of when special event closures are posted)

## Downtown 2-Hour Parking Effective March 1, 2025

Recently, the City, under the direction of City Council, **placed time restrictions within ALL parking lots and on-street parking, minimizing parking to a maximum of two** (2) hours. This change was implemented to allow the parking spaces to be turned over more frequently for the patrons and citizens who are visiting the Downtown area.

# **Public Parking**

- For patrons and businesses in the Downtown District
- Enforcement Hours: 7:00am–6:00pm
- No paid parking (except the Fourth Street Parking Garage)
- Free 2-Hour public parking within the following lots: Blount Harvey Lot, Harris Lot, Merchant Lot, Five Points Plaza, Hodges Lot, Chico's Lot, Edwards Lot, Dickinson Ave Lot, and Clark Street Lot; as well as 2-hour on-street parking
- All lots and on-street parking are time restricted with signs posted
- Once allotted time is expired, the vehicle must be moved to a different lot to avoid a citation (if the vehicle is parked on street, vehicle must move into a surface lot to avoid a citation)
- All Patrons and Employer/Employee lease holders are excluded from parking in the Atlantic Ave Bonners Lane Lot, Courthouse Lot, and Greene Street Lot.
- Employer/Employee lease holders are excluded from the Chico's Lot

## City Ordinance 10-2-104(B)

In all on-street parking areas and off-street parking areas, all vehicles shall be parked with the front of the vehicle positioned towards the front of the parking space and it shall therefore be unlawful for any person to back any vehicle into any on-street or off-street parking space (Ord. No. 23-045, § 4, June 8, 2023).
