Re: 2025 Youth Flag Football and Fall Future Stars

The Recreation and Parks Department welcomes the start of the 2025 Youth Flag Football program with record-high registration of 272 participants, reflecting significant growth and continued community interest in the program.

The program is open to boys and girls ages 5 through 12 and provides opportunities for skill development, teamwork and sportsmanship in a supportive recreational environment. All practices and games are being held at Evans Park, which continues to serve as a central and accessible location for youth and families.

In addition to Youth Flag Football, Athletics staff are gearing up for the largest soccer season yet with 1,333 participants. Participants range in age from 3.5 years old to 15 years old across eight different age groups. The success of this program would not be possible without the commitment from all parents and community members serving in volunteer coaching roles across the league. Soccer practices began Saturday, September 6 at Bradford Creeks Soccer Complex and continue until games begin on September 20.

Recreation and Parks staff accepted registration for six weeks through the City of Greenville's website and at various recreation facilities during operating hours for the above program opportunities.

Staff are committed to providing high-quality programs and services to the Greenville community. The department is encouraged by the increased participation and looks forward to another successful fall season. We appreciate the continued support in helping us provide high-quality recreational programming for the youth of our community.
