Re: Historic Preservation Commission Annual Presentation

The Historic Preservation Commission (HPC) is comprised of ten (10) members that reside within the City limits. Currently, there are two vacant seats. This past year the Commission has been busy assisting with the preservation of the Jacob W. Higgs House, reviewing and making recommendations on Façade Improvement Grants and a local landmark designation, and presenting Stewardship Awards.

Jacob W. Higgs House

This past year the Commission made a commitment to preserving the Jacob W. Higgs House. The property is a Local Historic Landmark for its association with local businessman Jacob W. Higgs as well as for its architecture. The property had been in a state of disrepair and had been ordered by City Council to be demolished due to its dilapidated condition. In March, 2024, the HPC approved a 365-day delay on the demolition of the property to allow more time for the property owners to work with Preservation North Carolina to market and eventually sell the home where a preservation easement could be recorded to preserve the structure. As the 365-day delay of demolition was set to expire, the HPC adopted a resolution requesting City Council to delay its order for demolition of the structure. At the May 5, 2025 and June 12, 2025 City Council meetings, HPC Chair Andrew Morehead spoke at both meetings to ask Council to delay the demolition. Ultimately, the property was sold to a new owner and preservation easement was recorded to preserve the property.

Façade Improvement Grants

The Commission reviews and makes recommendations to the City Manager on Façade Improvement Grants applications. The purpose of this program to provide an economic incentive to:

- Assist in the completion of substantial renovations to building façades within the core of the City's central business district;
- Encourage good design projects that capitalize on rehabilitation of the original fabric or design of existing properties; and
- Preserve the unique character of Greenville's Commercial Historic District and the Dickinson Avenue Historic District

This past year, two properties were awarded a total of \$6,084 from the program. to assist with the preservation/restoration of the buildings located at 530 Cotanche Street and 313 W. 2nd Street.

Local Landmark Designation

The O. B. Peatross House – Frances Speight and Sarah Blakeslee Home and Studio at 1910 E. 6th Street was designated as a Local Historic Landmark designation.

Stewardship Awards

Every other year, the Commission presents Stewardship Awards to individuals, organizations, or projects that demonstrate exceptional commitment to the preservation and protection of Greenville's historic resources. In May 2025, the Commission presented Steward Awards to the following organizations and individuals for their efforts in historic preservation:

African American Cultural Trail of Greenville-Pitt County Planning & Advisory Committee

Arthur Wallace 800 and 804 W. 5th Street (The Gold Post Restaurant)

Michael Glenn 310 W. 9th Street (Jefferson's Florist)

Justin Edwards and Israel Mueller 905 E. 5th Street (Walter Lancaster Harrington House)

Certificates of Appropriateness

From September 2024 to September 2025, the Commission acted on six (6) Certificates of Appropriateness.

Annual Plan

The Commission adopts an annual work plan every October that sets the goals and objectives.
