In 2009, a total of 3,989 first inspections took place. In 2008, a total of 3,744 first inspections took place.

Mr. Abboud: I would like to commend Code Enforcement for their work. Enforcement is noticed.

Ms. Diggs: Neighbors driving into driveway with two cars in a one car driveway making ruts.

Mr. Caspar suggested taking a photograph.

Ms. Diggs: Leaving a trash can out in front of the property.

Mr. Jones: That is a Public Works violation.

Mr. Jensen: What are the parameters for a fine?

Mr. Jones: It depends on the officer. A letter is sent asking for compliance. If resident will not comply, the resident is fined.

Mr. Jensen: How many repeat offenders are there?

Mr. Jones: There are a lot of repeat offenders.

# Flood Land Re-Use Program

Mr. Jones: After the flood of 1999, there were many properties purchased by the City. These properties were purchased under a program called the Hazard Mitigation Grant Program (HMGP). There are many properties now owned by the City of Greenville due to the HMGP. It is the City's responsibility to maintain these properties. Thus, a Flood Land Re-Use Plan was created. This plan allows for the property to be used in a manner "beneficial to the citizens of Greenville and at the same time safe from future flooding or storm events." Suitable land uses would be a flower garden, a produce garden, an open space, a recreation area and nature reserves. Unsuitable land uses would be any commercial use, hunting and new permanent structures.

Mr. Caspar: Is there a map of the area?

Mr. Jones: A map will be available at the February meeting.

Ms. Coles: I would like to introduce Kandie Smith, who is the City Council Liaison, to the Community Appearance Commission.

Councilmember Smith thanked the Commission members for their hard work and dedication.

#### Adopt a Flower Bed Program Update

Mr. Jones: Adopt a flower bed will be through Keep Greenville Beautiful. The program allows groups to adopt designated city landscape beds and maintain them by weeding, planting, collecting litter, changing out annuals and perennials, etc. An appropriate marker that is in keeping with the bed location will be placed in the bed identifying the group. The Community Appearance Commission will sponsor a bed.

Mr. Kachroo: I like the idea of having flower beds.
