**1. Action on District 1 community-wide meeting (September 2012)**

The NAB decided not to take action on holding a community-wide meeting in District 1 in September 2012.

## **NEW BUSINESS**

### **1. Overview of input gathered at 3-unrelated public meetings**

*Christopher Padgett, Interim Assistant City Manager and Chief Planner*

Mr. Padgett distributed a memo summarizing responses and questionnaires from the three public input meetings held by CDD staff in June 2012. Mr. Padgett explained that overall most residents who filled out questionnaires at these meetings were opposed changing the city's current definition of family, and even supporters of changing the standard cited the need for additional safeguards to mitigate crowded conditions.

## **DISCUSSION AND INPUT FROM NEIGHBORHOOD REPRESENTATIVES**

In their discussion, NAB raised several concerns that echoed residents' responses on the questionnaire distributed at the public input meetings and online, including who designed it and why did it presume a change to the rule; increased problems related to noise and parking; enforcement of occupancy standards; fire and other building standards; the current standard's effectiveness; and City Council's motives for suggesting a possible change.

Ms. Searfoss reiterated that staff was directed by City Council to propose alternatives that increase occupancy, and the questionnaire sought to collect information about people's suggestions related to higher occupancy—while also recognizing that attendees may not support any change and record that information as well.

Ms. Doherty clarified that she wasn't concerned about rental properties in her neighborhood as much as she wanted long-term neighbors to become stewards of the community. To her, long-term neighbors, typically homeowners, participate more in neighborhood projects and because they are permanent, it provides a feeling of safety. Ms. Hines repeated this sentiment, saying in her neighborhood, as homeowners age or pass away, transient renters do not show the same level of care and commitment that the previous homeowners did.

Ms. Maxwell said she has been looking at rental property with her daughter, and was more concerned about the internal conditions of rental property than the external effects of more unrelated people.

Ms. Maxwell handed out a statement that summarized the NAB's position on a change to the 3-unrelated standard (The NAB voted to support the current standard without concrete, well-researched alternatives). The statement concludes with the NAB recommending that City Council take a broader approach to neighborhood development to address the concerns raised through the NAB and at the public input meetings. All members, liaisons, and guests who commented on the memo supported this recommendation.

Mr. Smiley said that the NAB should be prepared to give something (i.e., higher occupancy) in favor of these standards to achieve a win-win situation. Ms. Searfoss pointed out that a “win” for property owners that support a change is clear-cut (i.e., higher occupancy), whereas broader neighborhood issues raised by residents opposed to a change needs further clarification.

Ms. Maxwell reminded members that the NAB voted in June 2012 to cancel its regular meeting (on Thursday, August 16, 2012) to attend the August City Council meeting to hear Mr. Padgett’s report on alternatives to the city’s 3-unrelated standard.

After the City Manager’s Office finalizes the agendas, Ms. Searfoss said she would send the NAB the dates and times of Ms. Maxwell’s annual update on the board and Mr. Padgett’s report on alternatives to the city’s 3-unrelated standard. Mr. Padgett advised members to arrive early, as City Council will have several lengthy items to discuss at both meetings.

**2. Appointment of representative to serve on Communities Putting Prevention to Work Grant Work Group (1 NAB member of liaison)**

Caroline Doherty volunteered to represent the NAB on this work group with the approval of NAB members.

**3. Staff Report**

Ms. Searfoss announced that she resigned from her position with the City of Greenville effective Tuesday, July 31, 2012. Ms. Searfoss thanked the board for its commitment and said she expects to see the board continue its excellent work.
