The City of Greenville Financial Services Department is pleased to present the latest edition of the Directory of Minority & Women-owned Businesses for the City of Greenville and the Greenville Utilities Commission.

Our Policy

It is the policy of the City of Greenville and Greenville Utilities Commission to provide minorities and women equal opportunity for participating in all aspects of the City's and Utilities' contracting and procurement programs, including but not limited to, construction projects, supplies and materials purchases, and professional and personal service contracts.

Goals

The City of Greenville and Greenville Utilities Minority and Women-owned Business Enterprise Program (M/WBE) is a voluntary goals program in construction, purchasing, and professional and personal services based on "good-faith efforts". These goals are established for a three-year period and achievement will be evaluated annually.

The goals of the **Commission** for utilization of minority and women business enterprises are:

Minority business participation in construction services 7%

Women business participation in construction services 4%

Minority business participation in supplies and materials purchases1.5%

Women business participation in supplies and materials purchases1.5%

Minority business participation in professional and personal services 2 %

Women business participation in professional and personal services 2%

The goals of the **City** for utilization of minority and women business enterprises are:

Minority business participation in construction services..... 10%

Women business participation in construction services 6%

Minority business participation in supplies and materials purchases. 2%

Women business participation in supplies and materials purchases. 2%

Minority business participation in professional and personal services. ... 4%

Women business participation in professional and personal services. ... 4%

Each firm listed in this directory is designated as a MBE, WBE, and/or DBE firm. **Only firms listed as MBE or WBE may be used to satisfy the above goals established for city and state funded projects.** If a firm is listed as both MBE and WBE, it may satisfy only one of the established goals. DBE firms are appropriate for utilization for federal NC Department of Transportation projects only.

Definition of MBE/WBE/DBE

Minority and/or Women-owned Business Enterprise (MBE/WBE)- a business that is at least fifty-one (51) percent owned and controlled by minority group members or women. An MBE/WBE is bona fide only if the minority group or female ownership interests are real and continuing and not created solely to meet the MBE/WBE requirement. In addition, the MBE/WBE must itself perform satisfactory work or services or provide supplies under the contract and not act as a mere conduit.

Disadvantaged Business Enterprise- small, independent business that is at least 51% owned by one or more socially or economically disadvantaged individuals. At least one of these owners must control the firm's management and daily operations, and the owners must share in the risks and profits commensurate with their ownership interest.
