GREENVILLE POLICE DEPARTMENT Consent Search Rights Form

In an effort to interdict the possession, sale, and distribution of illicit drugs and any other unlawful activity, it is sometimes necessary for the Greenville Police to go onto private property (all areas except inside the residence) to search for drugs, drug paraphernalia, and stolen property. Often illegal substances and/or evidence of criminal activity is placed on property by subjects who are part of the criminal element without the knowledge of the residents of the property.

This consent to search is valid until it is revoked by the owner or the responsible party for the property.
