The City of Greenville Recreation and Parks Department will receive informal bid proposals for the provision of site furniture and amenities at Town Common, 105 East 1<sup>st</sup> Street, Greenville, NC 278348. Companies that are interested in providing the required services are invited to submit a proposal, in electronic format only, to Lamarco M. Morrison, Parks Planner, at [lmorrison@greenvillenc.gov](mailto:lmorrison@greenvillenc.gov). Each company is solely responsible for the timely delivery of its bid proposal. All bid proposals must be received **by 2:00 pm local time on Tuesday, February 10, 2015**. No bid proposal package will be accepted after this deadline. Companies accept all risks of late delivery regardless of fault. Any bid proposal not prepared in conformance with instructions contained in the bid documents will not be considered.

**Project Scope:**

This project consists of a site furniture and amenities package to enhance the Phase I improvements at Town Common. The package shall include ornamental benches, picnic tables, recycling bin/trash receptacle combination and water fountains.

Bids shall be submitted for materials and equipment only; installation of the site furnishings and amenities shall be by others. Fees and charges for shipping, freight, and taxes shall be included shall be included in the proposal.

Bidders can submit a proposal for the entire site furnishings / amenities package or on individual components listed in Exhibit A – Site Improvement Amenities.

**Performance Specifications and Criteria:**

Bidders shall submit proposals based on performance specifications and examples outlined in Exhibit A – Site Improvement Amenities. Proposed amenities in proposals shall be similar in appearance, design and materials to examples in the performance specification. Requests for substitutions and approved equals must be submitted no later than Thursday, February 5, 2015 for approval. Any substitution submitted without prior approval will not be accepted.

**Above - Metal Ornamental Bench w/Back**

**Description**

Metal benches with back rest shall be 6', and center arm rest option – **five (5) total**, color shall be black. Examples of acceptable models are: Victor Stanley RB-28 Series backed bench, Victory Stanley RBF-28 with horizontal slats, DuMor Site Furnishings model 119 or approved equal.

**Below – Metal Ornamental backless bench**

**Description**

Metal benches shall be backless, 6' in length with center arm rest option – **five (5) total**, color shall be black. Examples of acceptable models are: Victor Stanley Steelsite RB-12 Series backless bench, DuMor Site Furnishings model 282 or approved equal.

**Above - Metal Trash Receptacle / Recycling Bin Combination**


**Description**

Trash receptacle / recycling bin shall be fuel recycler / trash receptacle with two round openings with 16 gallon liners, **three (3) total**, color shall be black or dark grey. Examples of acceptable models are: KAY model IVRC3R, Upbeat Site Furnishings model 51fSC-L1382, DuMor Site Furnishings model 435 in solid grey or approved equal.

**Below – Picnic Table**

**Description**

Picnic tables shall be powder coated metal– **five (5) total**, color shall be black. Examples of acceptable models are: Victor Stanley model FRST-6, Victor Stanley model A-426, Columbia Cascade Renaissance or approved equal.

**Above – ADA Water Fountain with dual pet fountain**

**Description**

Water fountain shall be surface mount with attached pet fountain, **three (3) total**, color shall be black. Examples of acceptable models are: Most Dependable Fountains model 410SM with pet fountain option , KAY , or approved equal.
