Site Visit on October 8, 2015

- 1. A site visit to each Fire Station in the contract was conducted immediately after the Pre-bid meeting was completed.
- 2. Walked around each Fire Station for visual inspection and discussion of work to be completed.

Clarifications & Requirements

- 1. Acknowledgement of all addenda received must be noted on the bid submittal form. Any and all addenda shall become part of the specifications and the bid package for the project.
- 2. All existing concrete curbs, asphalt, landscaping, sidewalks, etc. must be protected and repaired if damaged by the Contractor to current conditions at the end of the project.
- 3. City of Greenville will trim and remove the limbs from the side of the building at Fire Station # prior to the start of work.
- 4. Protect the sidewalks, landscaping, walls, etc. from loose paint chips or drops of paint.

- 5. All signs or labels currently on any painted surface shall not be covered with paint. Protect and cover prior to painting.
- 6. Water at each building can be used for pressure washing the buildings.
- 7. Pressure washing of the buildings includes all brick siding. Use appropriate cleaning agent and follow all manufacturer's instructions.
- 8. Cleaning of the gutters at each building shall be part of the bid and is to be included in the line item pricing for each building. Haul off all debris from sites.
- 9. All exposed metal lintels over windows and doors shall be painted as part of the bid for each building.
- 10. The accessory building at Fire Station #3 is to be included in the bid.
- 11. Exterior doors and jambs leading from the truck bays shall be completely painted.
- 12. Paint only the face of the doors and jambs in the truck bays that lead into the each Fire House.
- 13. The pass thru doors and jambs (2 each) located in the truck bay of Fire Station #3 shall be completely painted.
- 14. The painting of the shutters and the pressure washing of sidewalks are <u>not</u> part of this bid.

Bids are due Thursday, October 15, 2015 at the Public Works Building, 1500 Beatty Street, Greenville, NC. Bids will be accepted up to 2:00 P.M. There will not be a public bid opening. Bids will be opened and evaluated by staff and a bid tabulation sheet will be available upon request once the contract is awarded to the successful bidder. *Note: Mailed proposals will be accepted up to the 2:00 P.M. deadline. All proposals received in the mail will be stamped with the date and time or receipt.*
